With the long weekend coming up, I thought we might hold off asking for assistance until after our next conference call which is Sept. 13th. At that time, we can ask for names and phone numbers of SD Managers.

I spent some time with our SD Manager, Andrew Roberts last week and he is on-board from the perspective that the clinical lab is an SD opportunity. It may have possibilities. Shell COP and DuPont were the only Energy /Chemical companies I remember being present from this side of the Pacific, but the Chinese delegation had relevant members and the connection has been established. The USBCSD connection with the China BCSD could certainly be leveraged and Andy Mangan of the USBCSD would be very keen to get a tangible result out his organizations services, he needs a "win" to help build momentum and this could provide it.

I agree with Joe Machado, Chris Holmes (ex number 3 at the EPA by the way) would certainly be all over this in a heartbeat and would be a very good resource given his EPA background and long term affection for China, where he has lived in the past. Managing things through Andy rather than Chris might help things move at a more measured pace but Chris would certainly be invaluable. I know both of them well and can easily broker appropriate conversations.
