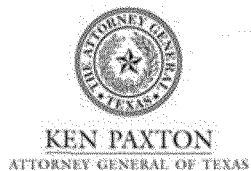

The topic of the meeting would be federal regulatory reform, an issue that impacts numerous cases that Texas is currently litigating. In May, AG Paxton led a 16-state coalition in calling on the Trump Administration to take action in accordance with two principles – restoring the role of Congress and ensuring impartial adjudications. AG Paxton would like to share his perspective on the proper scope of federal administration agencies as well as some ideas for practical reforms.
