My company is the consulting team to help gathering a planning information.

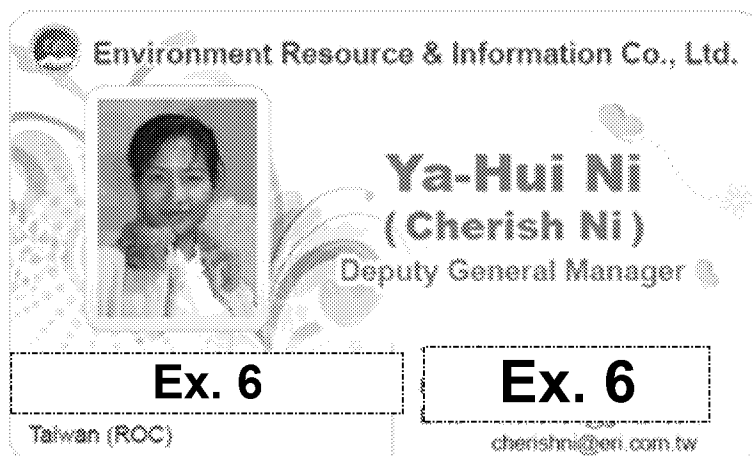
