Thank you so much for meeting with me today. I appreciated the conversation about coal policy and regulation in the context of the Trump administration and under the EPA leadership of Administrator Pruitt.

It was my pleasure to introduce the activities and programs of the American Coal Council to you. As mentioned, I extend invitation to your or another senior EPA representative to join us at our August conference to speak on the status of EPA regulations and regulatory reform relative to coal mining and use.
