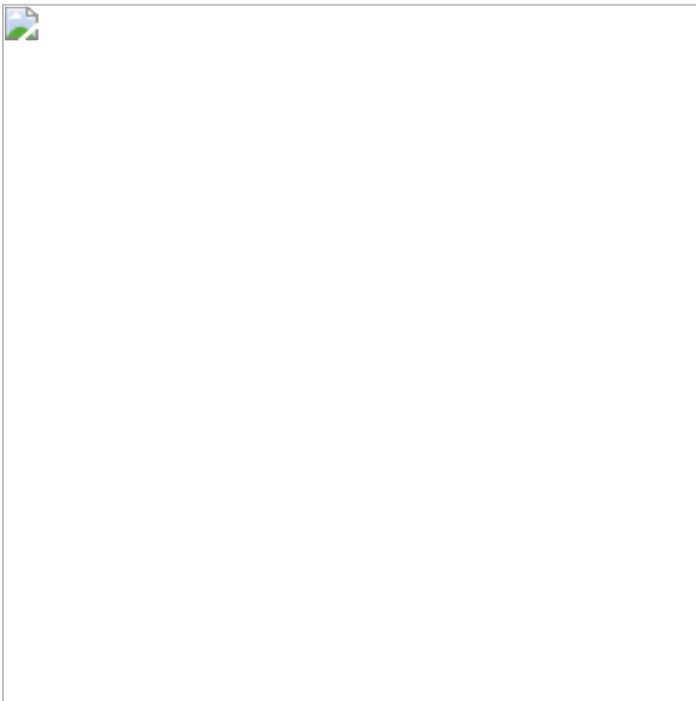
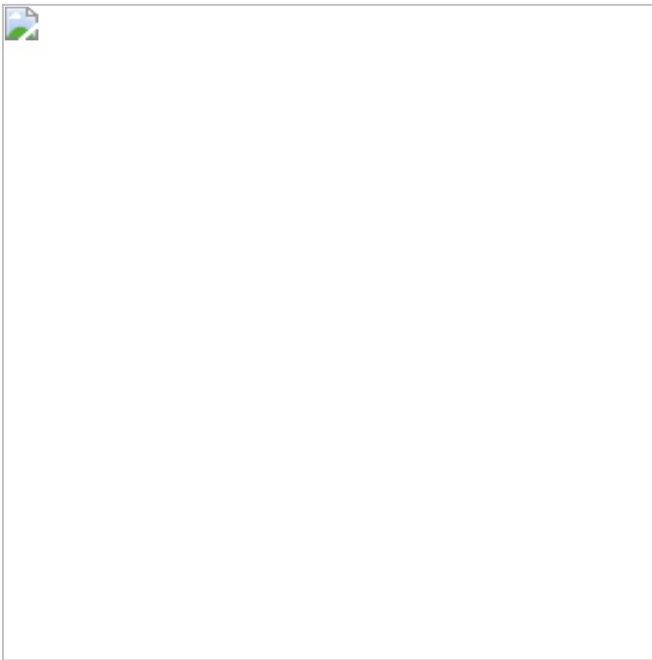

DOE Extends Third Set of LNG Export Authorizations

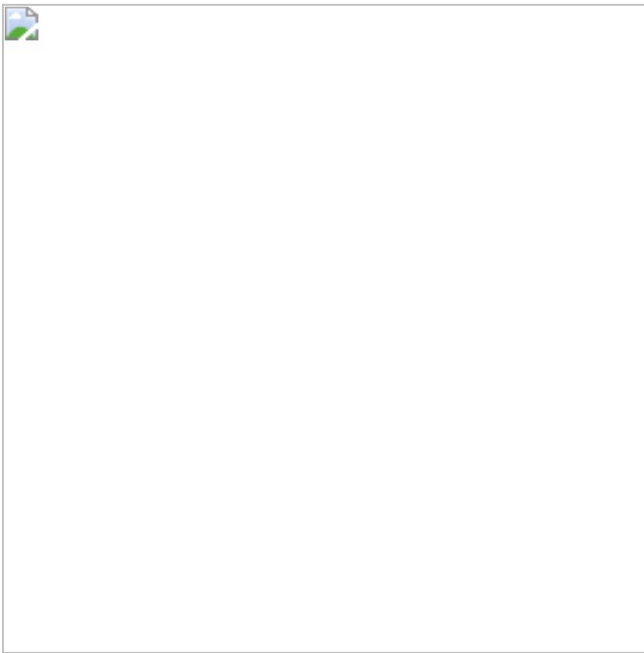


The Department of Energy has extended key natural gas export authorizations through 2050. This extension will help to further solidify America's role as a global leader in energy production, and energy independent at home.
