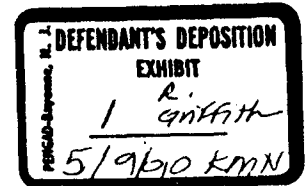

The deponent is required to bring to the deposition the following documents:

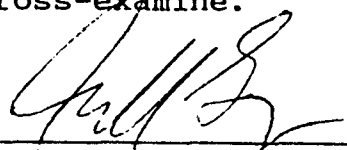

3. Any and all photographs or drawings that depict the shipment, receipt, use, storage or disposal of vinyl chloride at the Monsanto facilities in Springfield during the years 1947-1983
4. Any and all notes, drawings, papers, books and other writings relating to the operation of the Monsanto facilities in the Springfield area during the years 1947-1983
5. Any and all notes, drawings, photographs, papers, books and other writings relating to or written by John H. Warren.
