A Mr. Hardigg of the American Society of Mechanical Engineers is trying to get up some sort of a Manufacturers' Defense Association on behalf of the abrasive industries, and a Mr. de Blois, who used to be the head of the safety department of the Dupont organization is also trying to get together some organization for the benefit of the Rochester manufacturers.

I shall appreciate it if you will let me know some time whether you would wish to confer with any or all of these people or whether I should maintain the attitude that I have in the past of merely referring them to various government authorities in Washington.

My dear Dr. McConnell:

SUBJECT: Asbestos Dust at North Charleston Plant.

As you know, our plant at North Charleston, as well as the other Divisions, have been working with your Company for a long time in the acquiring of information, medical and otherwise, regarding Asbestos Dust hazards and Asbestosis.

We have had a number of suits, as you are aware, for which you have assisted us to prepare, and at the last trial, your Mr. Fehnel testified. We have depended on your Company to present certain information that our attorney, Mr. Julian Mitchell, of Charleston, S. C., desired, and we were at a standstill to know what to do and carry on with these suits, for I again say we had depended on your Company's assistance. Naturally, we were very much upset last week when Mr. Julliford reported that we could not expect any court assistance from your department, due to orders you had received from your superiors.

We immediately wanted to have you talk over the situation with Mr. Mitchell, to see what he could do, and when they got in touch with me and asked what I thought of subpoenaing Mr. Fehnel, I told them frankly that it looked to me as if that was the only thing we could do, if we were going to have the help of Mr. Fehnel in these particularly important cases. It may look odd to you that this subpoena was served, but really there was nothing else for us to do, and I could not see any other way out under the circumstances, after Mr. Mitchell had pointed out what it was going to mean to him to have Mr. Fehnel there. I do hope you will take this into consideration and that the assistance of Mr. Fehnel will be given us very cheerfully.

I can recognize the position of the insurance company in testifying in ordinary cases of this kind, but as I see it, these particular cases of ours at Charleston really come into a different category.

We carried Compensation and Health Insurance with your Company when these suits were first brought up at Charleston, and of course, under the policies, we were not covered against damage suits for Asbestosis.

The Metropolitan Insurance Co., nor no other insurance company in the United States, had any data that was worth very much on Asbestos Dust or Asbestosis, and naturally your Company wanted health statistics and information regarding Asbestos Dust on the lungs. Our Company was more than willing to cooperate with you, and we also induced Johns-Manville to cooperate, and your Company started with a Dust Survey of a number of the asbestos plants. When your appropriation for this work ran out, you requested that it be carried on until a new appropriation could be secured by your Company, and we did so. Later on, we hired a man, Mr. Binder, to work under your control, but at the expense of Johns-Manville and ourselves.

This all led us to believe that under the conditions, we would have your assistance in trying these unfair suits, which would eventually be a benefit to you, and also have considerable bearing on the Dust racket, about which so much has been published lately. I feel as if your Company has not taken into consideration all these various factors when turning down our request for Mr. Fehnel's presence at the trials in Charleston, Mr. Fehnel being the only man who has been following the details of the Asbestos Dust through all its various ramifications.

Naturally, if we could have foreseen the attitude the Metropolitan Insurance Co.'s Medical Department would take at this late date, we would have hired a specialist and he would have had all the data which your Company now has, and as you know, we have spent large sums to make the Charleston Plant an ideal one, with your assistance.

I do not believe that by Mr. Fehnel testifying at Charleston, it will establish a precedent, as it is hardly likely you will have this type of case come up again for many years, and I am also certain it is very questionable if you will get the same amount of assistance from any two companies that you have been getting from Johns-Manville and ourselves, and moreover, it was our intention to draw in other asbestos companies in this survey as soon as the time was right to bring them in, and this would mean a tremendous amount of information on Asbestos Dust and Asbestosis in the possession of the Metropolitan Insurance Co., who would be the only ones in the United States, so far as we know, having this information.

I have been trying to get in touch with my friend, Mr. James E. Kavanagh, Vice President of the Metropolitan Insurance Co., to endeavor to have him make an appointment with Mr. Ecker, your President, so I can go over this matter with him very carefully and thoroughly, and I hope to be able to do so next Tuesday. Unfortunately, I shall be away the latter part of this week.

My dear "Jeff":

I have your letter of the 27th, with reference to visit of Dr. H. F. Wilson, a representative of the South Carolina Board of Health, at which time, he requested that permission be given to the United States Department of Health to make an examination of the plant and take Xray pictures of our employees.

I have no objection to his making an inspection of the factory, but I hesitate at this time to permit an Xray examination of all our employees, for if these Xray records are going to be made available to all the shyster lawyers and doctors in the county, such as we have been up against the last couple of years, we may have an endless number of suits against us, especially as there are so few qualified doctors who can read an asbestosis Xray. This was verified to me in Peterborough this week, when I was talking to Dr. Faulkner, Commissioner of Health for the Province of Ontario, when he told me there were practically no doctors that could tell the difference between asbestos dust and granite dust.

For our own information, I should like to have an Xray of all the employees, and if we could get this information from the United States Department of Health without it being placed in the hands of every "Tom, Dick and Harry" in the country, I would be willing to let them make the Xrays, as it would be one way of getting them without arousing very much suspicion on the part of the employees. It would, no doubt, be interpreted as having some connection with the Social Security Act, but I certainly do not want to bring a lot of suits down on us just about the time we are getting through with the old ones.

Dear Mr. Mitchell:-

It was a great pleasure to hear from you this morning and I have read your letter with much interest. I knew something of this matter because it comes under the jurisdiction of Dr/ R. R. Sayers of the Public Health Service, who is in charge of the Office of Industrial Hygiene in the Service, which whom I have worked in close cooperation for over twenty years. I happened to meet him in Harrisburg the other day and he told me that the State of South Carolina had asked his assistance in making a survey of industrial plants in that State.

I think this will be very much to your advantage. Dr. Sayers has had wide industrial experience and enjoys the highest favor and confidence of industrialists and employers all over the United States. Whether he will make X-ray examinations of employees, I do not know, but I will ask Dr. Sayers, when he goes to Charleston, to get in touch with you.

The Public Health Service Reports rigorously follow a standard form, that is, their reports are published without mention of the firms or localities surveyed so that the identities of plants studied are not revealed. Thinking you may be interested, I enclose a copy of the report that Dr. Sayers made on Anthro-silicosis in the anthracite regions of Pennsylvania. This study was made at the joint request of the mine operators' association and the labor organizations. You will remember that when our asbestos study was published in the Public Health Reports, we simply referred to Plants, A, B, C, D, therein following the standard procedure of the Public Health Service.

No individuals' records are ever divulged by the Government. You may recollect that the Picker Clinic in Oklahoma was run jointly by the Public Health Service, the mine operators, and the Metropolitan. We had in our files the physical examination records of more than 50,000 individuals. We were often solicited by interested parties to permit them to have access to our records and our reply was always the same, namely, that they were Government records and not available for any purpose whatsoever, with the single exception of the United States Marshall in the performance of his duty in trying to apprehend criminals. I am sure that the Federal Department would not make available individual records to the State Board of Health.

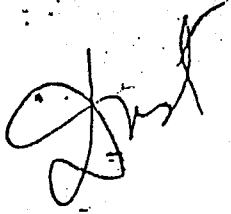
As a rule, the Public Health Service studies are published but I believe that this is not an invariable custom, depending upon their number and their general interest.

I am enclosing herewith a letter which I have written to Dr. Lanza, and would like you to read, and knowing that he is now in the service of his Country I am asking if you would do me the favor to forward it to him, and what I have said in that letter about the valuable services he has rendered I can also say with absolute sincerity that the services which you have rendered in helping me out of these cases in the past have been equally as valuable, and you have made a great many personal sacrifices to be present to testify and assist us. Personally I do not see how a man who is gaining in weight and working at the kind of job he has at the Navy Yard, down in the holds of ships, can be suffering from Asbestosis, though Dr. Smith in the letter he wrote to Mr. Mitchell said he was disabled as a result of the disease he had.

Dear Dr. Lanza:-

We may possibly have another suit based on alleged Asbestosis by one E. T. Hill, who worked with us for a good many years, and who was treated by Dr. Wild for pleurisy, and who only received during the time he worked with us sick benefits amounting to a little less than \$10.00, and left our employ to take a very arduous position with the Navy Yard at Charleston, where he is still employed. However, Dr. T. A. Smith, whom I consider to be a crank on the subject of Asbestosis, for as soon as he finds out that any one has worked for the Asbestos Company, he puts him down as suffering from a case of Asbestosis, has not only told us that this party has Asbestosis, from which he will die, but he told the party himself that he was suffering from Asbestosis.

A picture of this man's chest was taken by Dr. Taft in September, 1941, and another in November, 1942, and Taft's report gives no indication of any condition due to his employment. However, we are getting Dr. Taft to send his plates on to Dr. Fendegast, to whom you doubtless will remember you referred us to some years ago, so as to get another reading and interpretation of these plates and inasmuch as this claim may find up in the Courts, I am writing you with the hopes that you may be able to render us that assistance which has been so invaluable to us in the past.

Dear Mr. Brown:

Thank you very much for your check
covering the interpretations of films on Reynolds
and Leahy.

Like yourself; I am surprised that
they should reveal evidences of asbestosis-like
reaction in view of the limited exposure. I am
afraid I cannot agree with Lanza and McConnell's
interpretation as negative. Clearly, the films show
definite abnormal shadows. I wonder whether these
gentlemen could have examined the same films that
Dr. Sampson and I saw. In the case of Leahy, we both,
of course, recognized the present evidence of old in-
fection, but in addition to this, his films and
Reynolds' also show other more diffuse reaction which
I would only interpret as due to inhaled dust. As I
indicated previously, one would expect that other men
in the same group, exposed similarly should also re-
veal evidence of change.

I hope we may have the opportunity to
explore these effects further, both in subsequent films
of these individuals and those of other men in this
plant.

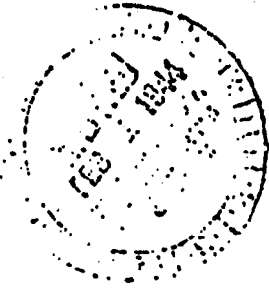

After our conference in New York in January about the Metropolitan Life Insurance report on dust counts taken in the textile mill, I arranged with the Industrial Hygiene Foundation of America to send one of their engineers here to take dust counts in various textile departments. I am quoting from the summary from the Industrial Hygiene Foundation report:-

"This is a report of a study undertaken to locate the most important sources of dust and to develop additional dust control measures at the Manheim plant of U. S. Asbestos Division of Raybestos-Manhattan, Inc. Sixteen dust counts were made in various departments. These samples indicate that conditions in the Picker House are not satisfactory but dustiness in the Carding, Spinning and Twisting Departments is less than 5 million particles per cubic foot. Recommendations are made that can lead to a reduction of dustiness in the Picker House as well as in the Carding Department. It is believed that while the card room is under considerable negative pressure the consequent starvation of the exhaust equipment is probably not in itself sufficient to account for any marked reduction in control of dust."

I am also including herewith a record of the dust counts taken in the various departments.

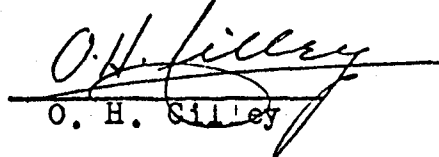
* In commenting on this report on the phone, Mr. McMahon, Managing Director of the Industrial Hygiene Foundation stated, that the control of dust in this mill was far above the average for an asbestos textile plant. He indicated that a dust count under 5 million particles per cubic foot is good. However we recognize that this is a continuing program, and we propose to first correct the conditions in the Ricker House at those points where the dust concentration is over 5 million particles per cubic foot. We then propose to make some changes in the card room, which will result in further improvement.

We are continuing to experiment with the application of oil to the fibre. We believe that this will result in further improvement throughout the plant.

Please consider this as a preliminary report as I plan to advise you from time to time of improvements that have been made.

A little later, after we have made some changes suggested by the Industrial Hygiene Foundation engineer, we shall arrange with Mr. Fehnel, of the Metropolitan Life Insurance Company, to make additional dust counts in our various departments.

as to the number of particles per cubic foot at the plant in Asbestos, Ontario?

A May I just reframe your question, sir. Asbestos, Quebec, not Ontario.

Q Asbestos, Quebec.

Q When were these studies? When did these studies begin?

A I don't know the exact date.

Q Approximately?

That you have given me regarding the technique and the desirable specifications of the X-ray machine is of great value and especially points out the mistakes involved in X-ray. So, of course, will purchase the larger machine as a result of your recommendation.

One of my good friends, Mr. J. E. Watts, is the manager of the General Electric X-ray machine with whom I conferred yesterday, and as he is expected to recommend the X-ray machine as preferable to others, and pointed out the necessity of the good service they offer in connection with the purchase and use of the General Electric machine. With the information you have furnished I am optimistic over the possibility of our creating a better defense than we have had before, and possibly having the Industrial Board to lean on the testimony of experts rather than the opinion of the country doctor who could not qualify as an authority on such cases as we have to deal with.

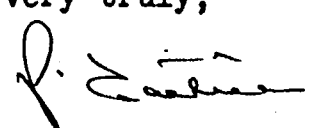
