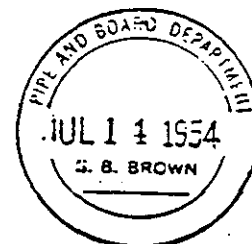

* C & G are to be submitted up to 10% for blue fibre in M-400 when available. Use ratio of one part C & G3 to one part C & G4. If intermediate steps are utilized, up to 10%, use the same blend number, but DEQ is to be advised.
