MAJOR SURVEY

The survey of the asbestos plants and mines started in 1934 has been concluded during 1936. This included a recheck survey of some of the plants to determine what improvements, if any, have been effected by the installation of certain equipment designed to control the dust, as well as a number of new plants, particularly on the Pacific Coast. Plants studied in 1936 were:

X-rays of the chests of exposed workers were sent in to the Home Office for diagnosis. In 1936 - 2570 X-rays were interpreted. Over, 3,200 X-rays of asbestos workers have been read in connection with the second asbestos study.

X-RAY INTERPRETATIONS

In addition to the 2570 X-rays of asbestos workers interpreted during 1936 the American Car and Foundry Company has been continuing to send in for diagnosis X-rays of their foundry employees. During 1936, X-rays of 177 of their workers were interpreted. We have also been asked to diagnose X-rays from other Group policyholders sent to us by the Group Claim Section in connection with claims.

SPECIAL RESEARCH

A study was made to determine a method of entrapping mercury and a chemical method of estimation of mercury in the air of a storage battery plant. This was necessary due to the fact that all available methods dealt with the determination of mercury in either the metallic state or in the forms of a

chloride or nitrate but not in the state of the oxide. Therefore, in order to determine the presence and concentration of mercuric oxide in the atmosphere of the plant in question a method giving concordant results was developed.

The presence of the oxides of nitrogen and their concentration in the fumes given off in acetylene welding were studied and a chemical method adopted which gave a true index.

Settled dusts of typical industries were studied and measured to determine the percentages of the various sizes present that might be considered pathogenic.

Various new atmospheric dust sampling devices were tried out under controlled conditions to determine their efficiency and comparison with the accepted standard method.

Methods for the determination of mixtures of acid fumes and solvent vapors are in process of study and development.

LABORATORY SURVEYS

Included in the above number of special services are 42 surveys made by the Industrial Hygiene Laboratory. In analyzing the samples of atmospheric dusts, fumes and gases collected in the plants studied, 819 analyses were made in the laboratory. The classes of materials analyzed were:

silica and silicates
metals (lead, zinc, copper, tin, mercury, etc.)
fumes (lead, zinc, mercury, solvents such as amyl acetate, methyl alcohol, dichlorobenzene, tricresylphosphate, etc.)
gases (carbon monoxide, sulphur dioxide, nitrous fumes, etc.)

These 42 surveys represent 8 more than were made by the Industrial Hygiene Department of Connecticut during 1936.

FIELD VISITS

During the year there were 85 field visits, exclusive of visits for laboratory survey. Included in this figure are 75 interviews in the Home Office.

ADDRESSES AND MEETINGS

Dr. McConnell and other members of the division attended 17 meetings of medical and safety organizations and made addresses at 7 of these meetings. Forty-eight newspapers and other publications gave press notices to these addresses in 505 column inches.

EXHIBITS

The Industrial Hygiene Laboratory held an exhibit at the American Medical Association meeting in Kansas City, Mo. In addition to a display of dust sampling equipment, 24 X-rays of chests of cases of first and second stages of silicosis and asbestosis, fungus infection, pneumoconiosis caused by exposure to amorphous silica were displayed.

An exhibit was also held of these X-rays at the Graduate Fortnight of the New York Academy of Medicine.

Dr. Philip Pierson, Clinical Professor of Medicine at Stanford University School of Medicine exhibited this collection of X-rays at an exhibit held in California.

PUBLICATIONS

Three booklets of the Industrial Health Section were completely revised and printed during the year. These are:

LITERATURE

During the year 1936, 11,557 copies of publications were sent to Group policyholders and non-policyholders. Of these 9,409 were sent by Welfare Division order but the letter was sent from this section.

LETTERS

Incoming letters numbered 1,798; outgoing, 1,511.

HOME OFFICE CONDITIONS

In addition to field surveys of the Industrial Hygiene Laboratory, the Industrial Health Section has been of assistance to a number of divisions in the Home Office Buildings in studying their lighting and ventilating problems. In

connection with the use of carbon tetrachloride in certain divisions in the Home Office to clean type a study was made of the concentration of fumes escaping and recommendations were made of safe methods of handling this solvent. We have also assisted the Physician in Charge of our Sanatorium in analyzing for toxicity the paint used in some of the rooms at the Sanatorium.

GROUP ACTUARIAL HEALTH CLAIMS

We are continuing to assist the Group Actuarial Division in analyzing the experience of Groups whose claim experience has been unfavorable in order to ascertain the cause. In a number of instances, where the claims would indicate a potential health hazard, we have found it necessary to visit these plants and make an inspection or survey. Reports of findings and recommendations of ways of controlling these hazards were submitted to the Actuarial Division in order to assist them in arriving at a decision regarding rates.

In connection with the practice of having Group policyholders defray incidental expenses of surveys, these have amounted in 1936 to \$3,406.20. \$509.53 of this amount has been incurred but not yet billed. This is a credit against our travel account.

PLANT SURVEYS

During the year 1941, 30 different industrial plants employing approximately 15,706 employees, were studied. Firms engaged in manufacturing heavy metals and printing plants comprise most of the firms studied this year. The industries studied may be classified as follows:

Metals	40.0%
Printing	40.0%
Chemicals	13.4%
Ceramics	3.3%
Textiles	3.3%

The samples collected necessitated making 1,112 separate analyses in the laboratory. A number of different substances which affect unfavorably the health of exposed workers was detected, such as dusts (silica, lead, arsenic, zinc, ganister, manganese); carbon monoxide; benzol, methyl alcohol, carbon tetrachloride, etc.

It has always been believed that employees in isolated locations in the plants, as for instance crane operators, were not exposed to gases and fumes, at least to concentrations not as high as the workers at the breathing level of the operation. However, we found that on certain operations where gas is given off that the crane operator has a higher exposure than those on the floor level, especially in connection with the lighter gases which tend to

rise to ceiling height. This was particularly evident in crane operator's cabs over the gas-fired soaking pits in steel mills and over galvanizing pipe operations where the men were exposed to excessive concentrations of zinc and lead fumes.

In addition to the above, the plants of three Group policyholders were visited and advice given regarding hazards or medical service.

Our policyholders have continued to send in for analyses, mostly for free and total silica, materials constantly used in the plant, as, for instance, bricks used in blast furnaces, pre-heating furnaces in steel and iron foundries, as well as abrasive powders used in the plants. We have also during the year analyzed materials used in our Home Office buildings.

Requests for assistance were received from thirty-two states of the United States, three provinces of Canada, from China, Santiago, Chile, and from Honolulu, Hawaii.

TRAVEL CREDIT

Although our budgetary allowance for travel during the year 1941 amounted to \$4,000, our actual expenses for travel amounted to \$239.67. Our gross expense for travel amounted to \$3,366.85, but credits received from Group policyholders for incidental expenses incurred while in the field amounted to \$3,127.18, making an actual expenditure of \$239.67.

RESEARCH STUDIES

A method for the determination of aniline was developed in order to determine the exposure of employees in a dye house at a cotton mill insured under a Metropolitan Group plan.

One of the large Groups engaged in the manufacture of steel uses bricks of a high amorphous silica content for furnace linings. Methods for the determination of crystalline free silica are fairly well defined, but the

determination of amorphous free silica in combination with combined silica, presents a very difficult problem. A fairly accurate procedure was developed.

Acrolein, a substance very irritating to the respiratory tract, is given off on the heating of animal and vegetable fats. As the binder used in core making contains high percentages of linseed oil, acrolein is present around core ovens and in the atmosphere of the foundry after pouring the moulds. A method for the sampling and determination of acrolein was developed.

Investigations of unsanitary conditions and possible sources of contamination were made of the plumbing system and in the Commissary Department of the Home Office.

Portable equipment was built for air sampling, using higher voltages for use in field surveys. Equipment for use on 25 cycle alternating current was perfected.

Studies are in progress of methods for decontamination in case of air raid gas attacks and for the control and protection of refrigerating equipment.

SPECIAL INQUIRIES

Six hundred seventy-four (674) special inquiries were received during the year. The information requested covered a wide range of subjects, such as the inauguration of a system of pre-employment and periodic physical examinations, installation of a medical department, toxicity of certain solvents, gases, and fumes. Many were occasioned by cases of illness among policyholders and certificateholders, usually chronic and severe, and are pleas for information as to where skilled and honest diagnosis can be obtained. All these queries are carefully considered and the effort is always made to put the individual in touch with the nearest competent medical treatment.

X-RAY INTERPRETATIONS

We have been continuing to read and interpret X-rays of the chests of employees of our Group policyholders. Five hundred twenty-five (525) were received during 1941.

MEETINGS AND ADDRESSES

During the year Dr. McConnell and Mr. Fehnel attended 28 meetings in different sections of the country. Some of the papers presented included the following:

"Mobilization of Industrial Hygiene for National Defense" - Chairman's address of the Industrial Hygiene Section of the American Public Health Association.

"Respiratory Diseases and Air Conditioning" - Second Symposium on Industrial Health held at the Medical College of Virginia.

"Medical Service in Industry" - Address before meeting of the Pharmaceutical Advertising Directors Club of N.Y.

"The Potential Hazards of Some of the Newer Solvents" - presented before meeting of the Medical Society of the State of New York.

Lecture on volatile solvents before a class of Navy medical officers at the College of Physicians and Surgeons.

Dr. McConnell addressed Dr. Flinn's class at Columbia University on "Ventilation and Air Conditioning". This class is composed of graduate students in industrial hygiene.

Dr. McConnell addressed a group of 96 foremen from the two Camden plants and the Philadelphia plant of the Armstrong Cork Company.

Due to Dr. McConnell's appointment as Consultant to the Division of Industrial Hygiene of the United States Public Health Service, it was necessary to decline the following speaking engagements:

1. Annual meeting of the National Safety Council - paper on Health Hazards and Their Correction in the Leather Industry.

Mr. Herbert L. Clover, Industrial Relations Dept. of the International Shoe Company also asked that Dr. McConnell give a paper on the leather industry at this meeting.

3. American Conference on Industrial Health - paper on Health Service in Small Groups.

4. Massachusetts Safety Council - dinner meeting with industrial key safety people.

5. Invitation to act as Chairman of Cold Committee of the American Association of Industrial Physicians and Surgeons.

6. Discussion of paper "Health of Executives", Association of Industrial Physicians and Surgeons and American Association of Industrial Hygienists at Cincinnati, Ohio.

LITERATURE

During 1941, 23,855 publications were sent on request. Of these, 20,189 were sent out through Welfare Division order, although a letter of transmittal was sent from this office.

CORRESPONDENCE

The incoming letters to the section during the year amounted to 1,980 and the outgoing numbered 1,190.

COMMITTEES

In addition to serving on a number of committees which have been active during the year, Dr. McConnell and others have been asked to serve on several new committees and reappointed to others in the year 1941.

Mr. Fehnel has been appointed a member of the Constitutional Committee of the American Industrial Hygiene Association.

Mr. Ferry has been appointed a member of a committee to draft a constitution and by-laws for the Greater New York Section of the American Industrial Hygiene Association.

HOME OFFICE CONDITIONS

Our assistance has been requested with increasing frequency by the different departments of the Home Office building charged with maintenance. These include queries regarding illumination, ventilation, health hazards of different operations, etc. We are also assisting with plans for air raids, especially in connection with decontamination procedure in case of a gas attack.

An idea of the range of these activities will be seen from the following:

Analyzed cleaner materials used in the Home Office; made 103 analyses.

Inspected exhaust hood. Recommended new type respirators.

Inspected complaint of cyanide cleaning bath in typewriter repair room.

Investigated use of carbon tetrachloride in Transcription Division.

Visited the Employment Section of the Personnel Division and the office of Mr. Wilson and Mr. Cunningham. Made recommendations re illumination.

Analyzed materials which were reported to have been used by a porter suffering from dermatitis.

Inspected illumination in new private dining room for executives.

Inspected complaints of ammonia in water supplies of Main Building.

Tested two sections of pipe from Printing Plant to determine cause of pipe failure. Tested also for corrosion pipe from Unit No. 6 pantry, warming cabinet and steam return line.

Visited a section where multigraphing machines are operating. A solvent (consisting of 90% ethyl alcohol and 10% acetone) is fed to a wick of these machines.

GROUP HEALTH CLAIMS

We have continued to cooperate with the Group Actuarial Division in an attempt to ascertain the cause of the poor claim experience of a number of Groups.

PUBLICATIONS

The booklet "First Aid Service in Small Industrial Plants" has been revised.

The leaflet "Hygiene for Working Women" has been revised.

Dr. McConnell prepared a paper on "The Industrial Health Service" for the Metropolitan Underwriter.

Reviewed proposed revision of American Welding Society welding handbook.

Reviewed article on Tuberculosis.

Reviewed revision of booklet "Industrial Safety Education in Schools".

Reviewed outline of Mrs. Bigler's handbook on nursing.

Reviewed and suggested changes in paper for Executive Service Bulletin on control of hazards in defense industries for the Policyholders' Service Bureau.

Reviewed revised edition of "First Aid".

Reviewed first draft of the "Report of the Workshop on Camp Standards" of the American Camping Association.

PLANT SURVEYS

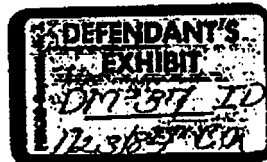
During the year 1942, nearly twice as many surveys were conducted as in 1941. The number of different industrial plants studied in 1942 was 58, as compared to 30 in 1941. As in 1941, firms engaged in manufacturing heavy metals comprise the major part of the studies, with ore mines second. The industries studied may be classified as follows:

The samples collected in the plants necessitated making 1,536 separate analyses in the laboratory. Analyses have also been made, as in the past, of materials shipped to the laboratory from plants of our Group policyholders. These tests were mostly for free and total silica. A number of materials used in our Home Office buildings has also been analyzed.

In addition to the above surveys, the plants or offices of three policyholders were visited and advice given regarding hazards or medical service.

Requests for plant surveys and information were received from Group policyholders and others in all lines of industry. To give an idea of the variety

RESEARCH STUDIES

Due to the increased number of requests for plant surveys resulting from the speed up in production, due to industry's victory effort, more routine work has been loaded upon the laboratory. This additional work has left little time for research problems. The laboratory staff did design and construct a new type of centrifugal pump which could operate on A.C. or D.C. current of 110-220 volts.

TRAVEL CREDIT

The amount of money expended for travel in the Industrial Health Section during 1942 amounted to \$4507.57. However, of this amount \$4047.63 was paid to us by the Group policyholders for expenses incurred by our men in the field while conducting plant surveys. Therefore, our total expenditure for travel for the year amounted to \$459.94.

SPECIAL INQUIRIES

Nine hundred thirty-seven (937) special inquiries were received during the year for information covering a wide range of subjects. This is an increase of 39% over 1941.

X-RAY INTERPRETATIONS

Before Dr. McConnell left for the Service, he had read and interpreted 158 X-rays received from our Group policyholders.

MEETINGS AND ADDRESSES

Dr. McConnell and other members of the staff attended 38 meetings during the year 1942. The following addresses were made:

Dr. McConnell made an address over Radio Station WABC on "Heat Stroke and Other Effects of Health".

Dr. McConnell gave a series of lectures to Naval medical officers at a training course in industrial medicine and surgery at the College of Physicians and Surgeons, Columbia University. He also addressed the Industrial Hygiene class at Columbia University and demonstrated our apparatus for collecting and sampling air.

Dr. McConnell continued during the spring semester a class in industrial hygiene at New York University. He had to secure a substitute for the fall semester due to his induction into the Army. Mr. Fehnel gave a lecture to this class on "The Conservation of Man Power".

Mr. Fehnel gave a paper entitled "Health Hazards in Steel Mills" at the joint annual meeting of the American Association of Industrial Physicians and Surgeons and the American Industrial Hygiene Association.

Miss Rantoul attended a meeting in Washington of the Committee on Standards for Maternity Care and Employment of Mothers in Industry.

LITERATURE

During 1942, 76,405 publications were sent on request, an increase of 31% over 1941.

CORRESPONDENCE

The incoming letters to the section during the year amounted to 2,242, and the outgoing numbered 1,368.

COMMITTEES

Members of the section have continued to serve on a number of committees which have been active during the year and attended a number of meetings. The following are new committees and others to which members have been reappointed during 1942.

New committees

A committee has been formed among Home Office building men entitled War Emergency Committee, to devise ways and means of equipping the Metropolitan Home Office buildings with protective devices in case of air raids. Dr. McConnell and Mr. Ferry are members of this committee and attended a number of meetings and rendered advice and assistance.

Dr. McConnell has been appointed a member of an advisory committee to prepare proposed industrial code rules relating to the revision of the Code on the Removal of Dusts, Gases, and Fumes at the New York State Department of Labor.

Dr. McConnell has been appointed a member of the advisory committee with Dr. Wittmer and Dr. Watson on intensive post-graduate instruction in industrial health by industrial physicians and the Faculty of the Long Island College of Medicine.

Reappointments

HOME OFFICE SERVICES

As in the past, our assistance has been requested on frequent occasions by the different departments charged with the maintenance of the Home Office buildings. These requests covered advice regarding illumination, ventilation, health hazards of different operations and materials used, etc. In addition, our office has been represented on the War Emergency Committee, a committee charged with the responsibility of plans for air raids in Home Office buildings. This entailed a number of conferences and testing of various materials to be used for protection. Dr. McConnell was in charge of decontamination procedure in case of gas attack. He gave a number of lectures on poisonous gases, methods of detection, physiological action, first aid treatment, etc. to members of the decontamination squads.

A few of the requests follow:

Information regarding inflammable solvents in use and methods of storage in laboratories.

Shatterproof tests on electric light bulbs covered with garinol were made to test its efficiency.

Information regarding control of refrigerants in case of a bombing raid.

Analyzed food from Home Office cafeterias.

Advice regarding elimination of faulty plumbing.

Analyzed specimens of urine of claimants for permanent disability.

Reviewed proposals regarding defouling stations on the Pacific Coast sent in by Dr. Shepard.

Inspected the Typewriter Repair Room to see if they had carried

out our recommendations regarding the use of sodium cyanide.

Information regarding a fire-proofing compound which is effective in preventing cloth from igniting and bursting into flame.

Analyzed sample of the lacquer cleaner which is to substituted for Utility Wash.

Analyzed sample of Protecto-Kote thinner.

Information regarding the formula for making "supertropical" bleach used to decontaminate floors, walls, etc. in case of a gas raid.

Temperature and humidity readings of eight of most congested air raid shelter areas in Home Office buildings.

Information regarding the composition of bottled gas.

Information regarding toxicity of fumes from creosote sprayed on wood in connection with a double indemnity death claim.

Recommended use of G-M-E 1 mask to be used by the attendant in the Sanatorium laundry to prevent inhalation of formaldehyde and ammonia fumes.

PUBLICATIONS

Report of the survey of the leather industry entitled "Health Hazards of the Leather Industry" was completed and appeared in the May issue of the Journal of Industrial Hygiene and Toxicology. Copies of this reprint were sent to industrial hygienists and those particularly interested.

Dr. Fred O'Flaherty of the Department of Leather Research of the University of Cincinnati arranged for the report of the leather survey to be reprinted in the trade journal "Hide and Leather".

Dr. McConnell rewrote his chapter in "A Textbook of Medicine by American Authors", edited by Dr. Russell Cecil.

Dr. Joseph E. Zbar, Editor of Philosophical Library requested permission to use Dr. McConnell's article on "Mobilization of Industrial Hygiene for National Defense" (which appeared in the American Journal of Public Health" as a chapter in a book on "Public Health in War Time".

Dr. McConnell prepared a "Memorandum on Protective Measures Against Common Implements of Warfare". This has been given a good deal of publicity and reprinted in the New York State Journal of Medicine. A digest of the article was published in "The Digest of Treatment" by J. B. Lippincott Company. The demand for this memorandum has been very great and it has created a good deal of interest.

Dr. McConnell wrote a paper on "Indoor Environmental Atmosphere and Its Control" for Medical Clinics of North America. Copies of this paper were sent to state industrial hygienists and to a selected mailing list.

Reviewed two articles by Dr. Victor G. Heiser of the National Manufacturers Association on "Defense Workers' Lunch Box" and "Pack a Lunch a Man Can Work On".

Reviewed Chapter II of the 1942 Guide of the American Society of Heating and Ventilating Engineers and gave suggestions for rewriting it.

Reviewed paper entitled "Physiological Reactions of Workers in Hot Industries with Atmospheric Conditions of Various Relative Humidities", published by the Research Committee of the American Society of Heating and Ventilating Engineers.

Reviewed pamphlet on "Health of the Workers".

Reviewed article for Nursing Bureau on "Communicable Disease Technique".

Reviewed revised edition of First Aid booklet.

Reviewed instructions to be sent to our nurses regarding their participation in air raid emergencies.

Reviewed and offered comments for revision of Rabies booklet.

Revised our booklet "Air Conditions and the Comfort of Workers".

Reviewed article on "Showers" to be issued by the Policyholders' Service Bureau.

Commented on paragraph on "Health Hazards in War Production Areas" which appeared in November 1942 Service Digest of Policyholders' Service Bureau.

Commented on new book issued by U.S. Department of Labor, Division of Labor Standards entitled "Arranging Shifts for Maximum Production".

Reviewed the revised edition of Conquest of Typhoid Fever booklet.

Prepared an article on "Rocky Mountain Spotted Fever" to be sent to an agent who is in Army.

Reviewed Health Bulletins for Teachers for the School Bureau.

Reviewed and offered criticisms on articles prepared by the Policyholders' Service Bureau and members of the Welfare Division on health hazards of industrial processes.

THE INDUSTRIAL HEALTH SECTION AND THE WAR

Since the outbreak of the war and before, there has been a great increase in requests from industrial firms for information regarding the hazards of processes and the toxicity of solvents and materials newly introduced in the plants in connection with the war effort. The following requests were received from firms and individuals so engaged.

Surveys

Ruberoid Co. (survey of four plants) - make asbestos roofing for government projects.

Republic Steel Corp. (recheck surveys of all plants and mines) - make shells and all kinds of steel

Blackwell Zinc Co. (survey of two plants) - supply zinc for war projects.

Geo. D. Roper Co. - make shells

General American Transportation Co. - make P.T. boats

Sundstrand Machine Tool Co. - make machine tools

Maremont Automotive Products (make springs and mufflers for tanks)

Asbestos Textile Corp. - make cloth and brake linings for government

Union Carbide Co. - (requested surveys of seven plants) - alloys for making steel

Kimball Piano Co. - make desks for the government

Armored Force, Fort Knox - study of armored tanks and army trucks

Armstrong Cork Co. - shells, insulation, linoleum for battleships, etc.

Walter Kidde & Co. - fire extinguishers

In addition to complete surveys, eighty nine requests for assistance were received from the above and other firms and individuals and from Navy and Army bases. These requests covered such subjects as adjustment of workers to changing shifts; relative hazards from electric shock from the use of alternating and direct current in welding; toxicity of emulsifying or wetting agents, chlorinated paraffins, and barium peroxide and other compounds; information regarding a twin chemical cartridge mask; hazards of explosives manufacture; hazards of handling TNT; substitutes for tetrachlorethane in airplane factories; recommendations as to how to handle an epileptic and fit him into industry; information regarding hospital-bed requirements in city to take care of increased personnel due to war work.

There has been a very increased demand for our booklets on welding, first aid service in small plants and the first aid booklet. The requests for assistance on methods of maintaining the health of personnel have also increased.

- - -

In 1941 Dr. McConnell was appointed a consultant of the United States Public Health Service to make a survey of the medical facilities available in industrial plants. This work necessitated consulting with the Directors of State Industrial Hygiene Divisions and visiting plants in Philadelphia, Pittsburgh, Jersey City, Trenton, Bayonne, Baltimore, Harrisburg, Lancaster, Lansing, Chicago, Louisville, Indianapolis, and Boston. In localities where these representatives of the Industrial Hygiene Divisions were to make the visits themselves, Dr. McConnell discussed with them the survey form to be used, methods of presenting the survey, etc. He personally made visits to 49 plants in different sections of the country.

Dr. McConnell reported for active service with the War Department on August 28, 1942.

Dr. Lanza has been made a member of the Board of Trustees of the Trudeau Sanatorium and Foundation.

A ventilation engineer is now available in the Laboratory of Industrial Hygiene for consultation in planning new ventilation and exhaust systems and necessary revisions of those in use.

We have secured the services of another chemist in the Laboratory.

The following are a few of the more outstanding research jobs conducted by the Laboratory.

The Rochester Gas and Electric Company was visited by Mr. Fehnel to outline and supervise a program for the study of atmospheric dusts and gas pollution. The company is planning to erect a new steam electric generating plant which will take about two years to build. The Metropolitan is to make studies each season of the year of the normal dust counts and supervise the study of the dust fall and sulfur dioxide concentrations in the City of Rochester before the erection of the plant. After completion of the plant and when it is in production, we are to supervise check studies to see if the plant causes any pollution of the air which will be detrimental to the health of people living in the vicinity of the plant. The Metropolitan was asked to do this work by the Rochester Gas Company on the advice of the Republic Steel Corporation for whom similar work has been done.

A study was made of the possible exposure of employees to hydrogen fluoride generated by the addition of sodium fluoride to molten steel when pouring rim heat. The study was made over a prolonged period to determine the extent of the exposure of employees before this method of making steel was put into operation. Recently a strike was called at the Ford Motor Company due to complaints of employees who had been exposed to the irritating fumes of hydrogen fluoride generated at a similar process. It is interesting to note that before any new process is developed or any new materials are used in the plants of the Republic Steel Corporation, the company requests the Metropolitan to make a study to determine the existence of any possible health hazards.

Tests were conducted on certain days of the week for three consecutive weeks in the carding room of the Manville, New Jersey plant of the Johns-

Manville Corporation to determine the dust pollution that could be expected when carding, and spinning four different mixtures of asbestos and cotton. This is another example of tests being made by the Industrial Hygiene Laboratory of contemplated processes in the plants of our Group policyholders before being put in production to eliminate any potential health hazards.

Triethylene Glycol Study

In certain areas in the new building (Unit 1) the air supplied to the sections is treated with triethylene glycol as a method of air sterilization. We have taken air samples in the sections with the impingers and absorption tubes and made quantitative triethylene glycol determinations. Considerable work was done in checking and adapting the analytical method used. By adapting a special filter, we were able to use our Electrophotometer in the analytical work in these determinations.

The results of our study to date indicate that the concentration of triethylene glycol vapors in the atmosphere is not at the optimum quantity and, therefore, no positive results are indicated nor can they be expected until the triethylene glycol concentration is increased until it reaches the bactericidal or killing range.

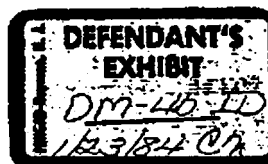
