

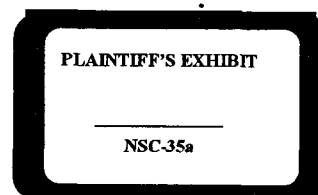

Our record permits us to keep close check on all transformer-bank loads. All bank locations and power circuits are shown on a map at maintenance headquarters to give us a clear picture of the location when trouble arises or when changes are contemplated.

Conclusion

The measure of good maintenance is the length of uninterrupted service of plant equipment. Most production lines are progressive, one machine depending on the adjacent one, one assembly line depending on the one before. However, maintenance men need not, and must not, sacrifice safety methods for experience. Frequently, temporary repairs can be made so that manufacturing processes are not unduly delayed and permanent repairs postponed until a shut-down period. However, extreme caution must be observed to prevent such postponements being overlong and safety sacrificed.

Maintenance personnel should be trained and experienced on all types of electrical equipment. There is possibly a greater degree of efficiency in having each man trained for a specific type of electrical apparatus, such as electronics, cranes, DC generators, air conditioning units, control panel construction and machine controls.

But, in case of an emergency the *specialist* may not be available; there may be two emergencies at one time. It has been our experience that a group of men who can do *all* the different types of work give us a more flexible working force and better job-as-a-whole efficiency.

In addition new men are more easily trained, employees co-operate with each other better, job-jealousy is eliminated, and less production time is lost.

Important Points

1. No person, except an electrician, should open or close a switch.
2. All motor starters should be **MECHANICALLY** blocked out before motor lead wires are disconnected.
3. Under no circumstances allow an electrician to work on high voltage equipment alone.
4. Insist on the use of safety protective equipment regardless of the time element involved.
5. Provide instruction classes for artificial respiration with frequent refresher sessions.
6. Inspect workmen's personal tools frequently and recommend their discard if unsafe for use.
7. Hold briefing session to check new building plans and machine moves for safety hazards. Gas-fired furnaces may be located near combustible or explosive material in the plans—correct them at the source.
8. Insist that areas where repair work is done is cleaned up after completion.
9. Never allow an employee to work a line *hot* unless absolutely necessary, and then only when equipped with the proper safety materials.
10. Ally your department closely with maintenance—you depend on them for hazard correction; they depend on you for advice and instruction.
11. Be on the watch for new and better safety equipment and see that the proper persons are informed.
12. Remember, inspections should be made of all electrical equipment that may in any way become a death-dealing or crippling device.
