REPORT OF THE TREASURER

The Treasurer presented a report of the expenditures from January 1 to April 30, 1945, which was approved, and is attached as Exhibit "A." In presenting this report, the Treasurer stated that the Association had a cash balance of approximately \$167,000 out of which the purchase of 7/8% Treasury Certificates of Indebtedness of Series E-1946 in the sum of \$100,000 had been ordered through the Chase National Bank in connection with the present war loan drive, the purchase to remain in the custody of the bank.
