<u>Date</u>	<u>Incident No.</u>	<u>Description</u>
4/5/84	84-4 (not issued)	Contamination of plant air header resulted in treatment of five people for CO exposure and two explosions and fires. (Devore)
4/19/84	84-5 (not issued)	Recordable injury - Pipefitter received 1st and 2nd degree burns to lower left forearm and 1st degree burns to neck and back when sprayed with molten naphthalene while disconnecting a barge transfer line. (McClellan)

3/23/84	C-84-02	Lost workday injury - Fuller-Austin employee sustained a severe laceration to small finger on left hand. (Supak)
