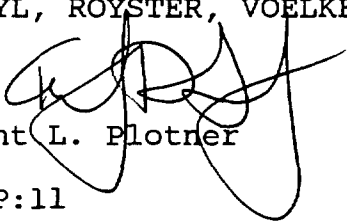
Dear Mr. Wolens:
