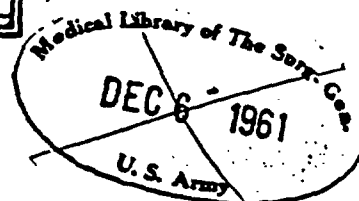
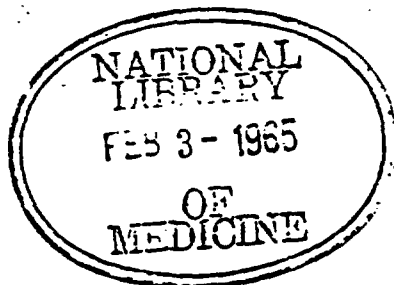

MINUTES

MEETING OF MEMBERS

Pittsburgh, Pennsylvania
October 26, 1961

The Annual Meeting of the Members of the Industrial Hygiene Foundation of America, Inc., was held at Mellon Institute, Pittsburgh, Pennsylvania, on October 26, 1961, at 8:45 a.m., pursuant to notice.

Dr. William P. Yant, Chairman of the Board of Trustees, presided. Dr. Yant commented on the excellent relations which the Foundation has had with the Mellon Institute since its beginning, first with Dr. Weidlein as President and then with General Ridgway. He then introduced Dr. Paul C. Cross who became President and Chief Executive Officer of Mellon Institute in September of this year.

Dr. Cross welcomed the guests and wished them success. He stated that the Institute is pleased to have the Foundation hold its meetings here each year and he extended an invitation that the meetings continue to be held here every year.

Mr. Theodore C. Waters, who had been previously appointed by the Chairman to examine the proxies, reported that there were 260 companies represented by proxies, that were in proper form and fully executed. On motion made and seconded, the proxies were approved. The member companies represented by proxy or in person constituted a quorum. A list of the member companies represented by proxies and a copy of the notice of the meeting and proxy sent to all members of the Corporation are on file in the Minute Book.

The Chairman called on Mr. E. K. Davison, Secretary, to read the minutes of the last Annual Meeting. The minutes were read and on motion duly made and seconded were approved. The Chairman stated that the Minute Book was available and open at the meeting for inspection by members.

The Chairman then called upon Dr. H. H. Schrenk to submit the report of the Treasurer. Dr. Schrenk reported that the Foundation is operating in the black, and that it is estimated that the year 1961 will be completed with a modest excess of income over expenditures.

Accordingly, at the beginning of the year 1962, the Foundation will have cash and savings account in the amount of about \$81,000.00. Based on a conservative estimate of income for 1962, a total budget of \$153,400.00 was suggested. Following presentation of this report, it was moved, seconded, and passed that the Treasurer's Report be accepted.

Dr. K. W. Smith moved that a contract for 1962 between Mellon Institute and the Foundation in the sum of \$150,000.00, covering the major cost of operation of the Foundation during the year 1962, be approved. This motion was seconded by Mr. Davison, and unanimously approved.

The Chairman reported that he had received the resignation of the following members of the Board of Trustees during the year 1961.

There being no other nominations, a motion was made, seconded, and passed unanimously that the persons named in the report of the Nominating Committee be elected to serve on the Board of Trustees for the year 1962.

Dr. Schrenk then read his report as Managing Director of the Foundation. A copy of this report, entitled Foundation Facts, is included in this report.

The Chairman then opened the meeting for discussion. He stated that a questionnaire had been sent to members to obtain information on environmental health problems which were of major importance to them. The information obtained will serve as a guide to direct research, field studies and services to meet the problems of the Foundation's members.

The Foundation had been considering a Seminar on Noise, but this was tabled pending an analysis to be made of the answers to the questionnaire. These answers should give us a better understanding of the areas in which our members are most interested.

Considerable discussion ensued on the program of the Annual Meeting—that it probably was too technical and subjects that would encourage management to attend might be more desirable.

Mr. Leo Teplow (American Iron and Steel Institute) suggested that more attention be given to the problem of rehabilitation both in the conferences and management sessions. This problem is becoming of increasing importance as both the work population and general population become older.

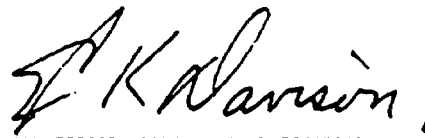
Mr. Waters expressed concern over the poor attendance and lack of participation on the part of the members at the Membership Meeting. He suggested more publicity and speakers of national importance to increase attendance at future meetings.

Dr. Paul W. Bachman (Koppers Company, Inc.) commented on a subject that is very important to the Foundation; namely, the establishing of contacts with individuals in member companies who would have a direct interest in the Foundation's activities.

Dr. Schrenk said that better liaison with some of our members is desirable and suggestions as to how we might better reach the persons in a company who should receive notices and other information regarding the Foundation will be welcome.

Mr. S. C. Rothman (The Boeing Company) said that he is in thorough accord with the statement that was made regarding publicity. He further stated that Industrial Hygiene Foundation is one of the finest educational mediums to present to management the importance of industrial hygiene and its coordination with safety programs.

There being no further business to come before this Membership Meeting, the meeting was adjourned at 9:35 a.m.

FOUNDATION FACTS*

More and more attention is being directed to the effects of the environment on the health and well-being of man. The public is concerned about radioactive fall-out, air pollution, food additives, stream pollution and even the exotic hazards of outer space. The publicity given to any one of these areas reflects on the others. A problem of this scope and public interest inevitably brings exaggeration, misinformation and demands for regulations and controls of hazards some of which are nebulous and ill-defined. These pressures frequently result in conclusions and actions which are not justified on the present state of knowledge.

It is reasonable to demand that the creation of new materials for the purpose of benefiting mankind carries with it the responsibility to make certain that the usefulness is not outweighed by risks to health. Our industrial, agricultural and economic progress is dependent upon our research and development. We cannot retrogress, neither can we afford to inhibit progress by unfounded fears and apprehensions. The same scientific endeavor, technical knowledge, and wise industrial administration used in developing new materials and processes can be used to raise the standards of health and welfare of workers and consumers alike. This concept is not new, and has been followed for many years, but we are now entering an era when greater emphasis must be placed on the health aspects than ever before.

During the past year, the Foundation has directed its efforts toward assisting its member companies to meet this new challenge through laboratory research, field investigations, training courses, seminars, and informational services.

Toxicological studies of the range-finding type completed on many products indicated that the oral toxicity of the majority was of a relatively low order. However, a significant number was found to have potential hazards owing to severe skin and eye irritation and a few from skin absorption.

Six major long-term projects in progress for over a year deal with fundamental and applied aspects of the carcinogenic action by intratracheal and skin application and with the pneumoconioses and related subjects. It was found that a quartz dust acting in conjunction with tuberculin on sensitized lung tissue invoked an exaggerated tissue response resembling experimental silicotuberculosis. Similarly, dead tubercle bacilli in conjunction with quartz also caused an inflammation which resembles tuberculosilicosis. In another investigation, it was found that when pulmonary edema was superimposed on lungs which were handicapped, either by a large dust burden or atelectasis, a greater incidence of mortality occurred than when the same degree of pulmonary edema was superimposed upon normal lungs.

Additional information was obtained on the basic reaction of the alveolar wall to chronic low-grade irritants, a reaction which is the initial process in a wide variety of chronic pulmonary diseases. Such fundamental information becomes more important as need to measure long-term effects of low level exposure to a multiplicity of contaminants increases.

In-plant environmental studies were conducted in potteries, foundries, chemical plants, a refinery and a limestone mine. Dusts, metal fumes, hydrogen sulfide, carbon monoxide, aldehydes, and diisocyanates were substances of major concern. These studies demonstrated an awareness on the part of management of the potential hazards associated with plant operations and the need for periodic, quantitative reevaluations to assure that control measures were being maintained in an effective manner. Engineering assistance was given to a member company in the design of a new plant to incorporate the most effective health protection measures. An outdoor sulfur dioxide survey was conducted during the summer and winter months to provide a continuing baseline of the concentration of this gas in the vicinity of the plant.

During the year, over 1200 abstracts were published in the Industrial Hygiene Digest. A list of the periodicals abstracted in the Digest was prepared and sent to our member companies. The Transactions of our 1960 Annual Meeting were published as the entire March 1961 issue of the Archives of Environmental Health. In addition, five papers were published and seven others were accepted for publication in technical journals. These papers presented data which add significantly to our knowledge of the response of the lungs to chronic irritants.

Technical information and advice was given by telephone and letter on a host of subjects covering all aspects of environmental health. One of our members, who had been

given specific information on their dust problem wrote and thanked us for this assistance and stated "Your advice and references have 'cleared the air' enabling us to face our atmospheric pollution with something more than doubt and suspicion."

A second training course for industrial hygiene engineers and chemists was conducted in cooperation with the Occupational Health Research Training Facility of the U. S. Public Health Service. An intensive two weeks was devoted to work in the laboratory and lectures. The response of those taking the course is evidence of the benefits to be derived from this activity and it is planned to repeat the course in 1962. A two-day seminar on the current aspects of the dust problem was conducted under the sponsorship of the National Industrial Sand Association and the Foundry Facing Manufacturers Association. This provided an opportunity for the members of these associations to obtain up-to-date information on the medical, engineering and legal aspects of problems associated with their operations.

The Foundation provides an opportunity for representatives of industry to come together as working groups to explore and better define what they are doing and to take leadership in planning and developing policies to anticipate and prepare for new problems which we must face in the future. The real strength of the Foundation is in the unified action of its members.

On behalf of the staff, I wish to express our deep appreciation for the helpful and encouraging support and the valuable contributions of the Board of Trustees and its Executive Committee, the Technical Committees, and the executive staff of Mellon Institute.

DR. BLAINE B. WESCOTT ELECTED BOARD CHAIRMAN

AND

THEODORE F. HATCH ELECTED TREASURER

At the Board of Trustees Meeting on October 26, 1961, Dr. William P. Yant resigned as Chairman of the Board, and Dr. Blaine B. Wescott was elected to succeed him. Mr. Theodore F. Hatch was elected Treasurer.



Dr. Blaine B. Wescott, Vice President-Research, Gulf Oil Corporation, has been a member of the Foundation's Board of Trustees since 1959.

Dr. Wescott first became associated with Gulf when he was on the Gulf Production Fellowship at Mellon Institute in 1927. Gulf Research & Development Co. was an outgrowth of this fellowship. From 1930-46 he was Chief, Materials & Production Chemistry Div. of Gulf. Since 1946, he has been engaged in the direction and management of Gulf Research & Development Co. In 1951 he was appointed Assoc. Director of Research and in 1954 became Executive Vice President and a Director of the Company. During the same year he was elected Vice President and a Director of Dominion Gulf Co. and of Gulf Minerals Co., and in 1955 was elected Vice President-Research, Gulf Oil Corp. In 1957 he was elected a Director of Callery Chemical Company.

During his career with Gulf, Dr. Wescott has been active in American Petroleum Institute work, and was awarded the API Certificate of Appreciation for work in promoting the API Standardization Program. He also received a Certificate of Service from the American Standards Association for work on war committees, and the Distinguished Service Award of the American Society for Metals for contributing to applications of alloy steel in the oil industry.



Mr. Theodore F. Hatch has been associated with I-H-F since 1945; as Research Director until 1949; as Research Adviser since then; and on the Board of Trustees since 1958.

Since 1949 he has been Professor of Industrial Health Engineering, Graduate School of Public Health, University of Pittsburgh, where he took part in organizing the new Graduate School of Public Health and Department of Occupational Health. Currently, he is also consultant to the Tennessee Valley Authority, Atomic Energy Commission, Army Chemical Center, U. S. Public Health Service, and numerous industries throughout the U. S.

Mr. Hatch has gained international recognition and has given lectures on occupational health in Sweden, Germany, Austria, Switzerland, Holland, England, South Africa, Colombia, Brazil, Venezuela, Chile, and Peru. He was the Senior Fulbright Scholar and Visiting Lecturer, London University School of Hygiene & Tropical Medicine in 1957 and also participated in a Symposium on Inhaled Aerosols and Vapors at Oxford University in 1960. In further recognition of his achievements, he has received the Legion of Merit (U. S.), Cummings Memorial Award of the Am. Industrial Hygiene Assoc., Citation of Excellence in Medical Authorship of the Industrial Medical Assoc., and Award of the American Society of Mechanical Engineers as organizer of Group on Human Factors in Engineering.

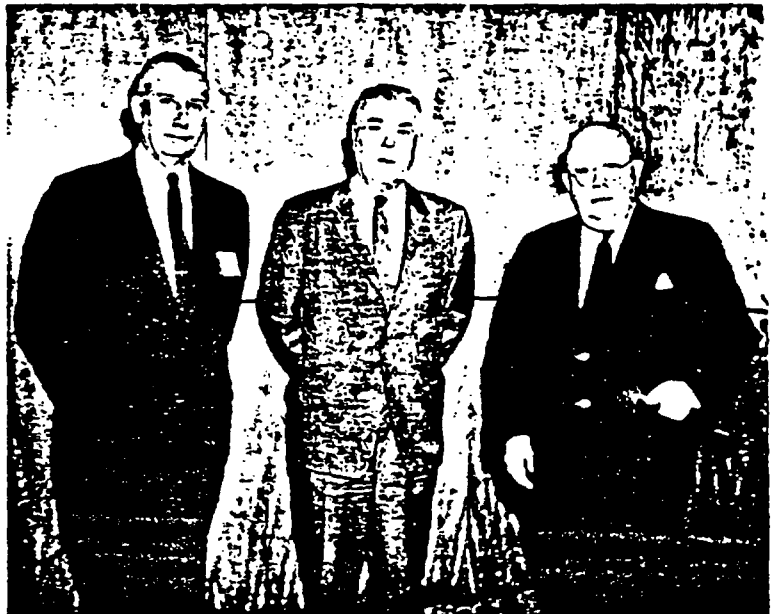

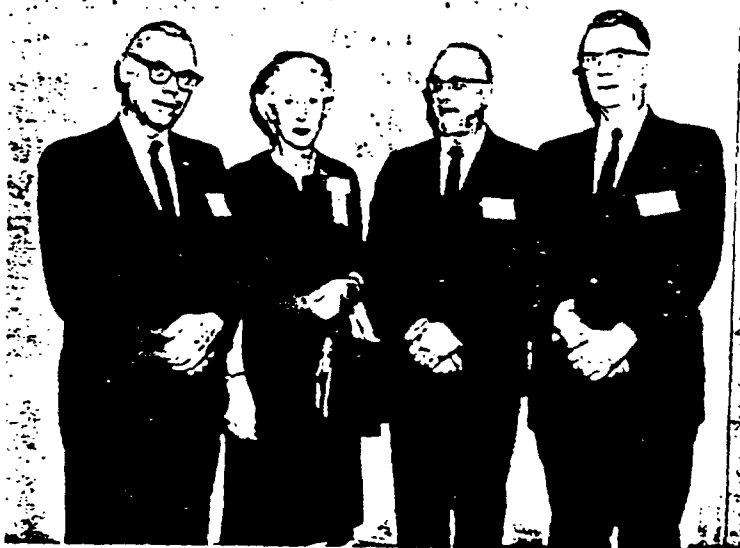

"Elevators in buildings have a passenger limit and theaters must limit the size of the audience.

"We have about reached the point where cities may have to set limits on the number of vehicles that may travel on highways whether they emit pollutants (into the air we breathe) or not."

Motorists-Dump Garbage

He added that "up to now we have permitted motorists to dump their aerial garbage wherever they chose, just as garbage and sewage used to be tossed into the gutters of our cities not so long ago."

He said it is natural to suspect both air pollution and cigaret smoking as a cause of lung cancer.

"We can and must reduce pollution to reasonable levels, but why imply that air pollu-

tion is guilty of causing cancer when the evidence is so scanty? Pollution is something that nobody wants and it's worth getting rid of whether it's the London or the Los Angeles kind."

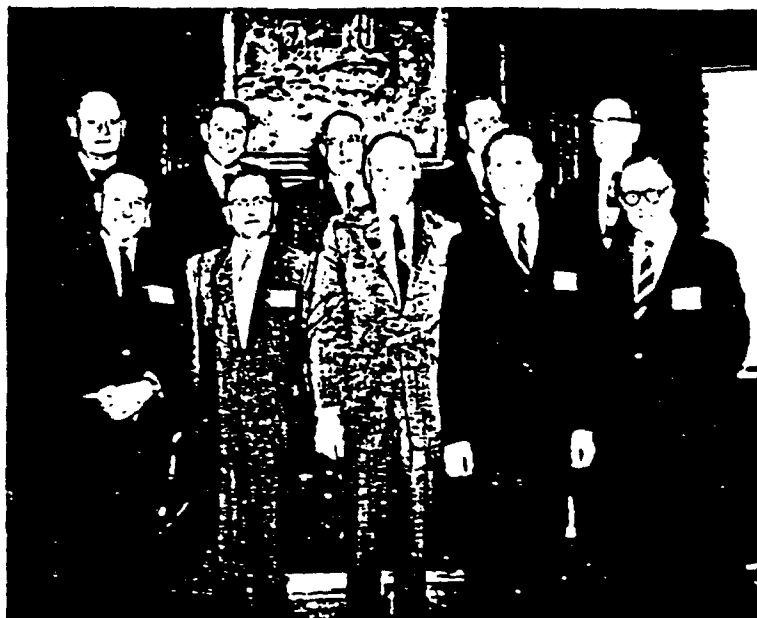

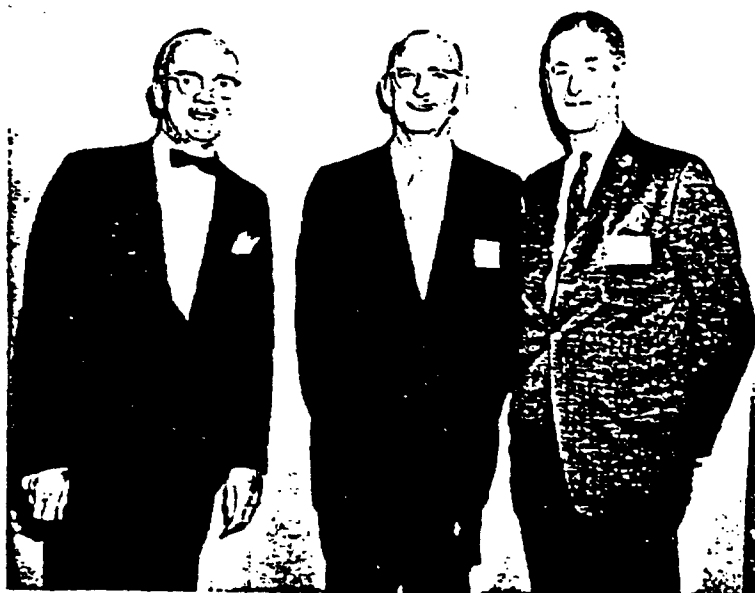
