My name is Jahan Wilcox and I work for EPA Administrator Scott Pruitt.

Off-the-record, EPA Administrator Scott Pruitt will be in Minnesota next Wednesday and was curious if you/WCCO-TV would like to have him in studio to talk about some Pruitt's goals for the EPA. Specifically speaking, we will be in Minnesota to talk about repealing the Waters of the United States Rules (WOTUS), but you can also ask him other questions including regulatory rollback, why he persuaded President Trump to exit from the Paris Accord, and general environmental questions. This would be an exclusive for WCCO as we would not go in-studio for a similar event with KARE 11 or KSTP.
