I hope you are well and enjoying your critically-important DOE role. We are thrilled and grateful to have your expertise at DOE!

Shell was part of a coalition that met with former Acting Under Secretary Steve Winberg about a month ago. He asked for a list of improvements to the next iteration of the 45v GREET model that could make the model more workable for the oil and gas sector. Shell teams identified five fixes that could improve the model. We requested a DOE meeting to share these ideas directly - but haven't heard back.
