We've been in touch with the Ben Guerir Energy Park on trying to visit there tomorrow afternoon. We should have an answer in the morning. We don't have any contact with the university down there, even though they are located next to the energy park, so we may have to do our best just to get in when we show up. If the Administrator's office has been in touch with OCP Policy Center on more specifics for the potential Ben Guerir visit, we would appreciate knowing what has and has not yet been decided.

We received confirmation of the meeting with MFA Secretary of State Boucetta for 2 p.m. on Monday the 11th. Her bio is attached—I don't think I had sent it before, since we had originally requested the minister.

In the same notice of confirmation of the Boucetta meeting, MFA informed us they are working to confirm a meeting with Minister of Justice Mohamed Aujjar, which would be for Tuesday the 12th at 11:30. His bio is attached. I will await your guidance as to whether or not we should pursue or turn off that meeting request—he and his Ministry are good USG partners on several programs, but the meeting is not a deal breaker for us. If we declined it, we could get on the road to Marrakech earlier, as we would have no meetings after the one with Minister of Energy Rabbah at 10 a.m.

I've attached an updated schedule reflecting these changes, though I have not yet added in the Ben Guerir stop. I've also added in the briefing with the acting Chargé and Deputy Chief of Mission for Sunday afternoon, but as discussed in the car, we could also have that on Monday morning.

See you tomorrow morning for the trip to Marrakech.
