reasonable fine and then let it go.—Miss F. E. Trautv.

A. After paying the fine, the law will also require the window to be installed. The window requirement is a state law and no court would cause you to be fined and then let the violation remain. The law also states that it is unlawful to maintain a violation of this kind.

Q. Sometime ago you issued a permit for the addition of several extra rooms to a downtown rooming house containing questionable occupants. Why does the law allow you to grant a permit for additional room for the reception of more questionable occupants? I note that beside your inspectors, you personally made an inspection also. I run an honest upright legitimate business next door and I cannot see why you are not more particular when issuing permits, by demanding references.—Miss O. J. L.

A. We cannot question the character or honesty of the owner or occupants of a building when issuing a permit nor can we demand references. I always try to make at least one or two inspections during the construction of important work in the downtown district, this is a part of my duty.

Q. Would I, a retired merchant, be permitted to build billboards and then rent the advertising space in same?—R. E.

A. No, you would then be in the out-door advertising business and would have to be licensed. As a licensed out-door advertiser you could carry on the business you window. Why not allow me to pay a mention.

Q. Recently a big man with a broad-brimmed hat said he was a building inspector and told me to take down the 18 sq. ft. cloth sign on the roof of my place of business. I took it down but where may I obtain a sign ordinance if there is such an ordinance and where can I put this cloth sign?—M. E. M.

A. Cloth signs are not permitted on the roof of any building. You could place the sign flat against the wall of your place of business for a period of 90 days. The city inspection department has a regular 24-page sign ordinance booklet for free distribution.

Q. The foreigner who lives next door to my place has erected a five-foot fence on his lot line between his place and ours, and the rough framing and rough posts face our house and the nice smooth boards, nicely painted, face toward his house. Would a foreigner be allowed to do this to me?—Mrs. De. Smith.

A. We have no building laws which would require a foreigner or anyone else to place the nice smooth painted side of the fence toward your house. The owner of a fence may face it either way.

Q. I recently placed a complete, fully-equipped bathroom in my house to accommodate four boarders. The bath was located in an inside, extra large 6x7 storage closet without windows. I don't want to give the complainants the satisfaction of seeing me change it by going through the expense of providing a window. Why not allow me to pay a mention.
