In terms of sampling, we will present guidance on sampling equipment to use and what not to use and provide references to allow attendees to follow up in more detail as required. Similarly, analysis will run through the most common analytical techniques for PFAS and the information that is provided. Most of the focus will be on soil, groundwater and surface water sampling and analysis but if there is another media that you are interested in let me know and I will see if we can cover that as well.
