***** Minutes *****

1. President John A. Brown, Jr., called the meeting to order at 9:30 A.M. and asked each person to stand and identify himself and his company affiliation.

2. The minutes of the last meeting were presented for reading. Mr. Peels moved that the reading be omitted. Seconded by Mr. Schuman. So voted.

3. The Financial Report was presented by Mr. E.A. Schuman, Treasurer. Mr. Peele moved that it be accepted, seconded by Mr. Hough, and so voted. The report is attached to these minutes.

4. Mr. T. Jay Flocken, Legal Counsel, discussed the background, statutory construction and means of enforcement pertaining to the Sherman Act, with particular emphasis on the per se offenses which have been established under Section I of the Act.

5. Mr. N.W. Hendry, General Sales Manager, Canadian Johns-Manville Asbestos Limited, Asbestos Fibre Division, presented a most interesting report on behalf of the asbestos fibre producers. The full text of his report is attached to these minutes.

6. Mr. Howard E. Shearer, Industrial Development Coordinator, FMC Corp. American Viscose Division, Marcus Hook, Pa., addressed the meeting. His subject, "Some Fiber Relationships of Interest to the Asbestos Textile Manufacturer", was most informative. Assisted by photomicrographic slides, Mr. Shearer explained the various steps in the manufacture of rayon and distinguishing features of the many descriptions of staple produced by the American Viscose Division. It was indicated that the uniform diameters and lengths of a crimped rayon with a serrated cross section; and its cohesive and processing properties enhanced by the presence of a delustrant and special lubricating finish, make such a staple especially attractive as a carrying fiber for spinning of asbestos. President Brown expressed to Mr. Shearer our appreciation for his fine talk.

7. The committee reports were given by the respective chairmen as listed below. The full text of their reports is attached to these minutes.

8. President Brown reported with deep regret the death of T.C. McCluskey, President of Tallman-McCluskey Fabrics Company, which occurred on July 18, 1966. Mr. McCluskey was a most loyal supporter of the various activities of the A.T.I., and had served as its treasurer in 1958, and as Vice President in 1961 and 1962. President Brown stated that he had written a letter of sympathy to Mrs. McCluskey on behalf of the Institute, and the letter is made a part of these minutes.

FIBRE COMMITTEE REPORT

The year 1966 has been a difficult one for the asbestos fibre producers in that asbestos fibre shipments were interrupted for a five week period in May and June by a stevedore strike at the St. Lawrence River ports. Secondly, a strike of the Canadian railroad workers occurred in the latter part of August and early September for a ten day period. Inflation is of increasing concern on the Canadian scene with labour assuming more militant tendencies and demanding higher and higher wages. New asbestos mines under development include the Clinton Creek operation of Cassiar which is scheduled for production in 1968. The Asbestos Hill development of Asbestos Corporation in the Ungava region of Quebec is scheduled for production in 1970. These two mining operations will produce additional asbestos cement fibres to supply the growing market in this field where the demand is increasing throughout the world. Countries in the Far East and in South America continue to expand their production of asbestos cement products with the requirement for asbestos fibres. The demand for asbestos fibres in brake linings particularly in the United States continues at a high level and this demand is expected to continue at the same strength providing the automobile industry continues to produce at a record pace. Also, the many miscellaneous uses for asbestos fibre continue in good demand and it is encouraging to note a broader usage of asbestos fibre from year to year.

Production of asbestos fibre in Russia continues to exceed that of Canada although sales outside the borders of that country are limited to Europe, India and Japan at a rate estimated at 175,000 to 200,000 tons per year. Difficult times are being experienced by T. & N. in Southern Rhodesia whereby the asbestos fibre from that country is being embargoed in many countries of the world and we see no early termination to the problems related thereto. The economy of North America continues at a high level and no indication of a slowdown in demand for asbestos fibre is yet apparent although it is expected that the continuation of the tight money policy in the U.S. and Canada will have its effects in the near term. The currency problems of many countries in South America has lessened during the past two years and this has resulted in a higher demand for asbestos fibre in many of the South American countries. The economy of Europe continues at a high level with the exception of the United Kingdom where severe problems indicate difficult times for the year 1967. Certainly, the problems in the United Kingdom will affect the asbestos industry in the near term. The demand for asbestos fibre in the Far East is continuing to grow at a rapid rate with the increasing production of asbestos cement products. It is expected that these markets will continue to grow at a rapid rate providing currency problems can be solved and providing that external forces do not disturb the normal political situations.

Concern has been registered regarding the possibility of asbestos as a health hazard such that it is pertinent to mention that the Quebec Asbestos Lining Association has embarked on a broad medical study which will involve the expenditure of substantial sums of money. Three very competent medical personnel have been retained to conduct basic studies on asbestos fibre from the standpoint of its effect on the health of human beings. Sufficient information is not yet at hand to provide the basis for any publication and it will be some time before such is available.

Bausch and Lomb Automatic Dust Counter

Mr. Nelson of American Smelting and Refining Co. gave a demonstration of the Bausch and Lomb 40-2 Automatic Dust Counter. The Committee was impressed with its simplicity of operation and its versatility.

It is portable and can be carried around with ease, and requires no special training to operate. Maintenance is practically nil. By a simple adjustment the range of particle size to be counted can be changed. It also has the advantage that it gives instant and continuous readings which, with the addition of a recorder, makes it possible to set the equipment up at a given station and monitor the atmospheric conditions for extended periods of time.

The present cost of the instrument is \$3,800. plus \$800. for the recorder.

It was suggested, for consideration, that the A.T.I. purchase one which could be rented or loaned to individual member companies.

There was also some discussion on literature received from the Union Industrial Equipment Corp. which described the Unico Cassella Gravitimetric Dust Sampler. This instrument still requires manual counting the same as the Greenberg Smith method.

Environmental Health Survey

A letter from Dr. Lewis J. Cralley was read in which he stated that they expect to complete the in-plant phase of their study within a year from this fall.

The Sales Promotion Committee met on October 6, 1966. All member companies were present except H.K. Porter Co. and Tallman-McCluskey Fabrics, Inc.

As a result of a direct mail campaign to a selected list of colleges and universities with Engineering Departments, we have had some response in the matter of interest in using our A.T.I. Exhibit in their schools.

The display has been sent to Alfred University School of Ceramics at Alfred, New York, assigned for the fall semester until February 1st, 1967. We have tentative assignment of the exhibit for Stevens Institute of Technology, Hoboken, New Jersey, from February 1st, 1967 to June 1st, 1967. We have possible interest from South Dakota School of Mines for some later date.

At an appropriate time in 1967, we will send out a similar, direct mail letter to the remaining portion of the mailing list of universities.

A report was made that a small quantity of Japanese made Asbestos Cloth has been reported sold in the midwest area as low as 46¢ per lb. This situation is being watched carefully.

Final decisions on all copy has been made for publishing the Third Edition of the Asbestos Textile Handbook. We have coordinated in the Handbook all of the ASTM specifications revised and approved by ASTM for our publication.

Contract has been let for publication of 12,500 copies to Confort & Company, New York City, with an approximate six weeks' delivery promised as of October 17th, 1966.

The Sales Promotion Committee agreed to recommend to the Board of Governors sending a copy of the A.T.I. Handbook to all important engineering school libraries.

Discussion took place as to the advisability of expanding our inter-member reporting of business levels of production and sales of individual companies to supplement Caruso reports. No decision was concluded.

A supplementary meeting was held with all interested A.T.I. members concerning recent adverse publicity of asbestos products as written in Chemical Week Magazine. Members of the Asbestos Fibre Committee and the Technical Committee joined with the Sales Promotion Committee in this discussion. Sitting as a Committee Of The Whole, it was felt advisable to register with Chemical Week our concern of their irresponsible article in the September 10th, 1966, issue.

Thru our legal counsel, we plan to register our dissatisfaction both verbally and in written form.

We rejected at this time a plan of trying to obtain a written statement from either Dr. Cralley or from the Industrial Hygiene Foundation which could be used by sales organizations to refute adverse publicity.

SUBJECTS DISCUSSED:

Revision of ASTM Specifications

In order to give an intelligent report of the meeting on Thursday, October 6th., it is necessary to describe the activities of the committee since the June meeting.

Following the June meeting, the committee reviewed and reported discrepancies in the 1966 ASTM preprint on D315, D1571, and D2100. These were reported to Paul Smith, ASTM.

In the meantime a conflict in use of terms was noted wherein the word "Type" was used in two places to imply different meanings. In D315 and D1571 Types 1 to 5 designate the various kinds of yarn that can be used. In D2100 Types 11, 1V, and VI designate the magnetic rating of various asbestos textiles.

In order to avoid the conflict it was recommended that the word "Class" be used in designating the kinds of yarn used in D315 and D1571 and the word "Type" be retained in D2100. In order to give all members of the committee an opportunity to express confirmation of the change, a letter ballot was mailed by the chairman to each member with the request to vote for or against the change. The response was 100% for the change.

This information was relayed to Paul Smith for proper changes in the ASTM draft and also to Bill Hough and Howard Bain for proper insertion in the new A.T.I. Handbook. This completed the committee's work in assisting Sales Promotion with the A.T.I. Handbook.

Copies of the 4th. Draft of D1918, as set up at the June meeting were distributed to all members and a copy to Dr. Scroggie. Comments and recommended changes on this draft were received from Dr. Scroggie in July. Copies of his comments were sent to all members prior to the August 18th. and 19th. meeting.

On Thursday August 18th., the committee set up the 2nd. Draft of D299 yarns. Bill Hough, chairman of the Sales Promotion Committee met with the committee that day and his assistance was greatly appreciated.

On Friday August 19th., Dr. Scroggie met with the committee and with his assistance a better arrangement of the specification was formulated. Time did not permit at this meeting the consideration of the various equations involved.

Following the August meeting several exchanges by correspondence have been made within the committee and with Dr. Scroggie on the equations involved in D1918,

At the present meeting on October 6th., consideration was given to D1918 and so far as the editorial script is concerned, agreement seems to have been reached between the committee and Dr. Scroggie's committee. The equations are yet to be resolved.

Due to the urgency of completing the revision of the specifications, the committee felt that an intermediate meeting should be held. Decision was to have this on Thursday and Friday, December 15th. and 16th., 1966 at ASTM Headquarters, Philadelphia, Pennsylvania.

Subjects Discussed

1. Mr. Dewey Childers of H.K. Porter discussed the present status of a test procedure he is trying to develop to determine the spicule content of milled textile grade fibers. So far, results have been inconclusive. By the time of the next meeting he hopes to know definitely whether his apparatus will function well enough to do the job he wants.
2. Members of the Fiber Testing Committee representing both fiber producers and consumers plan to attend the next meeting of ASTM Sub Committee A-4 on Asbestos Textiles which meets in New York City the 19th of this month.

One of the items scheduled to be taken up at this meeting is the revision of ASTM test procedure D-1118, which is the procedure for determining the magnetic rating of asbestos.

Since the magnetic rating test presented in our test manual is patterned very closely after the ASTM procedure, the Committee feels we should follow any proposed changes in the ASTM procedure very closely to see if the proposed changes might suggest any modifications to our own procedure.

Results of the ASTM deliberations will be reported to Committee members at the next meeting.

3. The Committee discussed a situation that arose occasionally in which test values for fiber openness or surface area reported by a mine sometimes differed

appreciably from the values found by the fiber purchaser on the same lot of fiber. It was agreed that this problem arose when the miner made his tests on fiber before it was packed in shipping bags and the purchaser made his tests on packed fiber removed from the bag. The effect of packing makes a big difference in fiber openness test values.

This situation emphasized the need for both the miner and the purchaser to condition and prepare the fibers in the same way before any tests are made on them. At present the best procedure we have for this is outlined in the first test in our test manual under Method of Sampling and Preparation.

4. Mr. Gay Brink of Asbestos Corporation briefly reviewed for the Committee the results of the recent meeting of ASTM Committee D-30 on Inorganic and High Modulus Fibers. This is the committee established a few years ago to handle standards and test procedures on fibers and whiskers made of such materials as boron, carbon, aluminum oxide and other materials as well as on asbestos.
