I trust you are well, I'd like to briefly come back on the restriction proposal and kindly ask for a meeting at your earliest convenience.

Last week we discussed the proposal with our national members, including technical experts and we point out the following:

- The textile-relevant derogations requested after March have been mostly ignored; the need for fulfillment of standard is acknowledged only for water repellency
- There has been change in the formula of substances excluded the designation (page of the annex 2 , left column, last point) this suggests market disruption favoring some non-EU production
- The current proposal significantly diverges from the SEAC recommendation. i.e. moving from "protective professional textiles" to "textiles for the protection of workers that must meet durable water repellency (DWR) performance standards;" there is a huge gap. This leaves unsolved the issue of how to ensure oil, chemical protection etc. for individual.

We look forward to discuss these points with you, meanwhile I hope you may take this points into account in the next steps of this restriction

Last Thursday we have spotted the EC proposal for annex XVII restriction update as notified to the WTO, ref. enclosed annex. I first wonder whether the enclosed document is the corrected final draft or else, if mistakes may have occurred.

Looking at the annex I point 3, we are glad to observe that the concept of 6-years-derogations needed to enable compliance with standards for protection of workers was apparently well received during the inter-service consultation.

We appreciate that.

That is indeed the point we made since the meeting in March and which we then attempted to further support with evidences gathered in the following weeks.

We were utterly surprised to see that, apparently, such concept is accepted but it is minimized to a fraction of its applications range, namely is referred to textile protecting vs water repellence and workers only.

Most of the evidences we received from companies do refer to PFOA-needs related to textiles for the protection of individuals (including but not limited to workers) against more critical threads, such as chemicals, oil, military defence etc.

In conclusion, if the enclosed text is the correct results of the internal consultation, we do not understand how can the standard-compliance concept be recognized but excluded for most of the relevant applications and people categories.

Any of your considerations will be highly appreciated.
