In reply to your letter of April 30, 1958 concerning VNDA-9022 White 605 and VNDA-9025 White 605, I would think that both of these formulations would be satisfactory for the packaging of drug and cosmetic applications. There might be a question regarding the use of DOP in materials which have a high oil content since this compound is not acceptable for food packaging use in oily foods. I am not qualified to comment on cosmetic purple, but I would suspect from its name that it would be satisfactory.
