**Administrator Pruitt to Attend Bilateral Meetings with
U.S. Partners in Morocco**

*Visit to promote exportation of environmental technology
and innovation*

WASHINGTON, DC (December 11, 2017) - U.S. Environmental Protection Agency (EPA) Administrator Scott Pruitt will attend bilateral meetings in Morocco this week, where he will convey U.S. priorities for environmental cooperation and innovation.

Administrator Pruitt will attend various meetings from December 11-13 in Rabat and Marrakech, Morocco. He will meet with Moroccan leaders, including members of the King's Cabinet, to discuss the environmental chapter of the U.S.-Morocco Free Trade Agreement. Members of Administrator Pruitt's senior staff will participate in a roundtable with U.S. companies to discuss exportation of environmental technology and innovation. Administrator Pruitt is the first of President Trump's cabinet to visit Morocco, ensuring the Administration's environmental priorities are conveyed with our partners abroad and collaboration between the two countries is ongoing.
