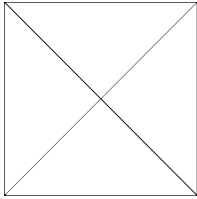
We have also invited some of your colleagues at Interior and EPA including, David Bernhardt, Timothy Williams, Patrick Traylor, and Mandy Gunesakara.
