Regarding your request for data on trace elements
in Monsanto's Santocel C and 54, we have data only
for the following:

Santocel C:

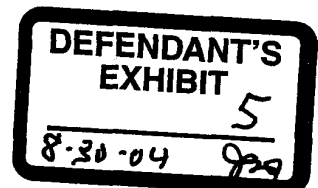
Arsenic (As)	< 3 ppm
Heavy Metals (Pb)	< 30 ppm (1)
Lead (Pb)	< 10 ppm

We do not have any data on Santocel 54, but would
expect to have the same typical values as Santocel C.

- (1) Food Chemicals Codex test for common metallic
impurities (Ag, As, Bi, Cd, Cu, Hg, Pb, Sb, and
Sn) that are colored by Hydrogen Sulfide under
the conditions specified in the test.

Your letter of July 23 addressed to Monsanto's Mr. Roy Carlson has been forwarded to me for response relating to Santocel 62, Aroclor 1254, Aroclor 5460, Aroclor 6062 and EMA-81.

In response to your request for concentrations of trace elements present in these products, I have the following to offer for Santocel 62:

Arsenic	< 3 ppm
Lead	< 10 ppm
Heavy Metals (as Pb)	< 30 ppm
Phenols	None detectable

Information relating to trace elements in Aroclor 1254 and EMA-81 is not available at this time, however, we would not expect these elements to be present in any pollutionally significant amounts.

I have enclosed Material Safety Data Sheets covering Aroclor 1254, EMA-81 and Santocel 62, a Santocel Toxicity and Safe Handling statement and a product specification sheet for Santocel 62 and Aroclor 1254.

Because of environmental considerations, Monsanto discontinued the manufacture and sale of Aroclor 5460 and Aroclor 6062 several years ago. Therefore, the information requested for these two products should no longer be required.
