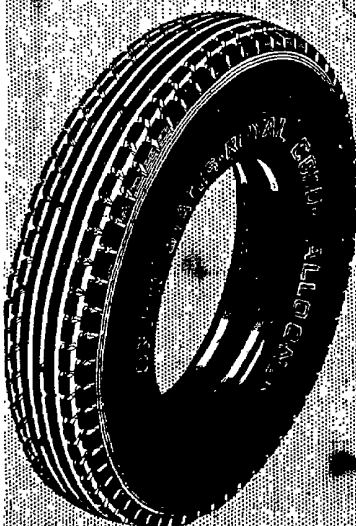

TEN WITNESSES CALLED TO STAND IN MURDER CASE

Ten witnesses for the prosecution were examined yesterday in superior court in the trial of John J. Neumom charged with murder following the death of Robert L. Powers, a motorcycle officer June 10 after a collision between Neumom's automobile and the officer's motorcycle. Trial of the case opened Tuesday before Judge Haines and a jury composed of eight women and four men, almost the entire day being spent in selection of jury.
