There is perhaps no other metal that has been so intensely studied by governmental agencies and the industry itself as to its toxic effects on man. Despite the tremendous amount of scientific data available, controversy as to what does or does not constitute a hazard continues. Lead and Zinc, like copper, come from Sulfide ores -- probably over 90% of all primary lead & zinc, in fact. The elimination of SO_2 discharge into the atmosphere is a serious problem. One authority estimates that Zinc Smelters contributed close to 17%, lead, over 7% -- while copper smelters expelled over 75% of all smelter SO_2 .

By way of perspective, that 100% of smelter SO_2 is but a small fraction of industrial air borne pollutants -- and it has been estimated that all industry contributes only 17% of all air-borne pollutants in the United States.

David Swan joined Kennecott Copper Corporation in 1966 as Vice President-Technology, having come from Union Carbide Corporation where he served in various capacities, and, finally, Vice President of Technology of the Metals Division and General Manager of the Defense and Space Systems Department of that corporation.

Mr. Swan attended Rensselaer Polytechnic Institute and received the degree of B. Met. E. in 1940. From 1942 to 1946 he served in the United States Naval Reserve, attaining the rank of lieutenant commander.

Mr. Swan served on the Board of Directors of The Metallurgical Society, as Chairman of the Institute of Metals Division, and as Chairman of the Niagara Frontier Section of AIME. He is currently President of the Smelter Control Research Association, Vice President of The Metallurgical Society of AIME, Chairman of the Environmental Matters Committee of the American Mining Congress, and Chairman of the Technical Development Committee of the International Copper Research Association. He is Fellow of both The Metallurgical Society (of AIME) and American Society for Metals.

In 1957 Mr. Swan was a member of the exchange delegation of the United States metallurgists visiting the Soviet Union under the sponsorship of the U. S. State Department. From 1958 to 1962 he was a member of the Materials Advisory Board of the National Academy of Sciences - National Research Council, and in 1959 served concurrently on the NAS-NRC special committee reporting to the President's Science Advisory Committee on the "Scope and Conduct of Materials Research". He continues to serve on special committees of the Materials Advisory Board.

In 1959 Mr. Swan presented the Orton Lecture before the American Ceramic Society, and in 1965 was the recipient of the Albert Fox Demers Medal presented by Rensselaer Polytechnic Institute. He is the author of several patents in welding and metallurgy. He is a member of the Board of Directors of Quebec Iron and Titanium Corporation, Quebec Metal Powders, Ltd., The American Institute of Mining, Metallurgical and Petroleum Engineers, and of William F. Clapp Laboratories of Battelle Memorial Institute.

BIOGRAPHIC STATEMENT

Dr. Vaun A. Newill was born in 1923 in western Pennsylvania. He graduated from Avalon High School in Pittsburgh in 1940; from Juniata College, Huntingdon, Pennsylvania with a B.S. degree in chemistry in 1943; from University of Pittsburgh with an M.D. degree in 1947; and from Harvard University with a S.M. Hyg. degree in Epidemiology in 1960. He interned at St. Francis Hospital, Pittsburgh, Pennsylvania and completed a residency in Internal Medicine at the Veterans Administration Hospitals in Buffalo, New York and in Cleveland, Ohio.

Dr. Newill was elected to Delta Omega while at the Harvard University School of Public Health and has been a member of Sigma Xi for many years. He has membership in a number of societies such as the Air Pollution Control Association, American Association for the Advancement of Science, American Federation for Chemical Research, American Public Health Association and the American Thoracic Society. He has published more than twenty-five scientific papers covering a wide range of subjects but relating primarily to diabetes mellitus, information retrieval, and environmental factors affecting the health of people.

Dr. Newill's past work experience has included a short period in general practice in Harrisburg, Pennsylvania, two tours of duty with U.S. Navy, twelve years on the faculty in the Departments of Preventive Medicine and Medicine, School of Medicine, Western Reserve University and on the staff of University Hospital, Benjamin Rose Hospital and Veterans Administration Hospital, Cleveland, Ohio. He has been a consultant to the Summer Epidemiology Training Program of the Department of Health, State of California, a Visiting Lecturer in Epidemiology at the Harvard University School of Public Health and now has an appointment as an Adjunct Associate Professor in Epidemiology at the University of North Carolina School of Public Health.

Dr. Newill is, at present, Director of the Division of Health Effects Research, National Air Pollution Control Administration. He joined the Division of Air Pollution in 1965 and spent the first two and one-half years on assignment in Japan reviewing the Tokyo-Yokohama Asthma problem among American military personnel assigned there, becoming acquainted with air pollution health effects research underway in Japan, and in helping establish cooperative air pollution health effects studies between investigators in the two countries. On return to United States in June 1967, he became Chief of the Ecological Research Section of the Health Effects Research Program. In August 1968 he assumed his present duties.
