Hi Margie,

I'm sorry for the delayed response, I am only working intermittently during the shutdown. BLM Alaska is using FY 18 Oil and Gas Management appropriations to continue work related to the NPR-A Integrated Activity Plan. This money will be used for labor and operations for staff involved with the public meetings. Three BLM staff including myself are working to execute the public meetings for the IAP. Work may continue on these projects as long as appropriated funds remain. We are only working as much as we need to accomplish the IAP public meetings, and after that we will return to furlough status unless funds remain and we are directed otherwise.
