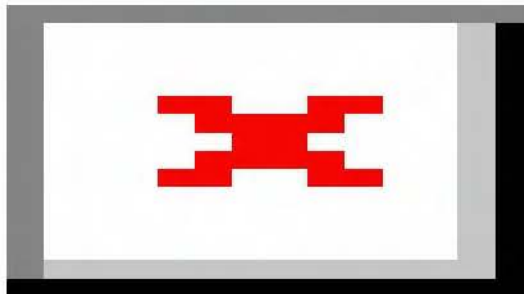
Izzy,

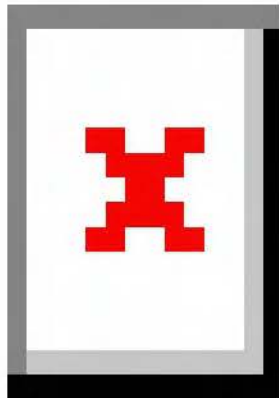

Featured Keynote Speaker



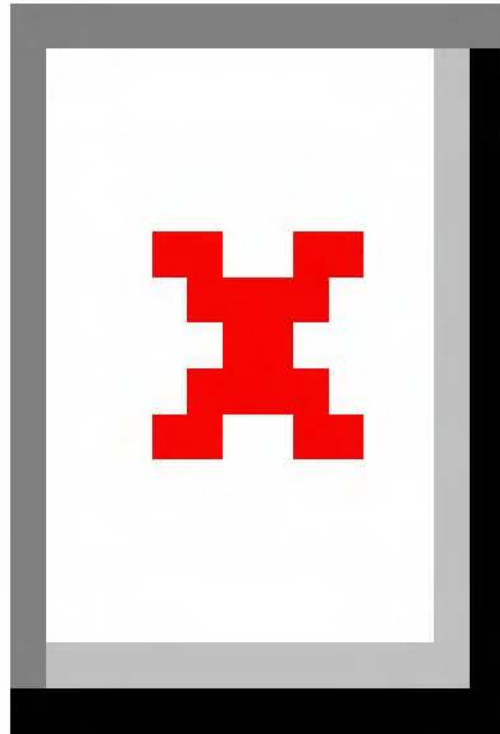
GLENN YOUNGKIN
