I attached a map to the Whitten building. The entrance for visitors is marked in red. In case you can't see the map, here are directions in text:

Follow 12th street across the Mall.

At Jefferson Drive, turn right. (This is right after you pass the Metro exit for Smithsonian on the mall)

The Whitten Building is on your right

Enter in the center of the building along the curved driveway with the flags outside.

Alternatively, you could take the Metro from Federal Triangle to Smithsonian and exit at the MALL exit and then follow the above directions to USDA.
