Good afternoon. Andria requested that we get you copies of the most recent Reform Plan information. These following attachments were provided by Mariel:

1. **Agency Reform Plan 081817:** This document includes the agency reform plan that was submitted and includes updates (in tracked changes) that Mariel made following discussions she had with Andria.
