Attached is a list of products (mainly Gibbsboro specials) which contain lead in excess of 1% which you requested.

Three of these items - C91 W F1, C91 W F2, C91 W F3 - are specification items, therefore the lead cannot be removed and still meet specification. Mr. Lennotti informs us that Cleveland is now doing work on the new Federal Specification which eliminates lead and which will undoubtedly replace all of these items, even though one is a Pennsylvania Highway Department specification (C91 W F1), the other two being Federal Specifications (TT-P-).

We are therefore transferring the control of these items to Cleveland. By a copy of this letter we are informing Mr. Gabbart and Mr. Schefft of this action, as undoubtedly very shortly the three will be dead items.

If you do not agree with the decision of these items or feel that Gibbsboro should do some of this work rather than Cleveland, please call and we will discuss it.
