Dear Ms. Miller:

Please be advised that Judge Kirner has finally rescinded his Order Disapproving Compromise and Release and issued an Order Approving Compromise and Release pursuant to my letter to him dated March 23, 1993. Unfortunately, although the Order Approving includes a release of death benefits it does not indicate a Thomas finding or that rehabilitation is settled. I recommend that you go ahead and comply with the Order and make the payments indicated below, but I will write to Judge Kirner requesting that he issue an Amended Order that includes a Thomas finding. Please find attached hereto a copy of my letter to Judge Kirner.

The award is for \$500.00 less \$50.00 attorney's fees to the Law Offices of Michael Calvert. Accordingly, payment should be made as follows:

To Law Offices of Michael Calvert as attorney's fees - \$50.00

To applicant - \$450.00

If any permanent disability advances were made, these should also be deducted from the applicant's portion, although it is my belief that no such advances were made.

Please pay the award on or before May 19, 1993 to avoid any claims of penalty and interest.
