Re: the ORMS effort on EO 13771, who is/are the special uses and hydropower specialists on that team?

Regarding geothermal resources, while it is a source of renewable energy, the FS manages it under the minerals program, and we do so with the BLM (b)(5);Deliberative Process Privilege
