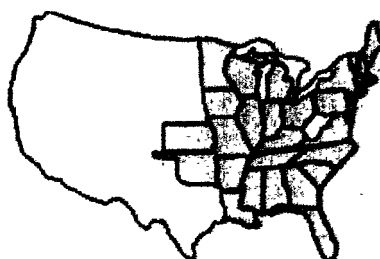

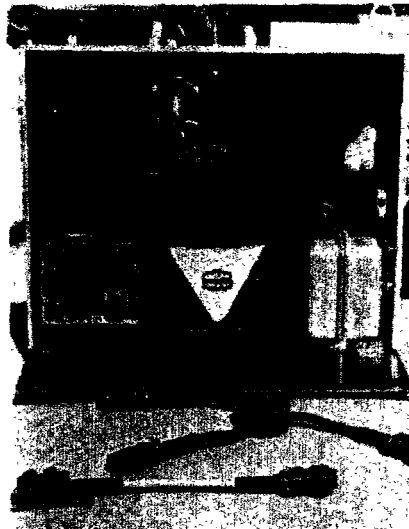
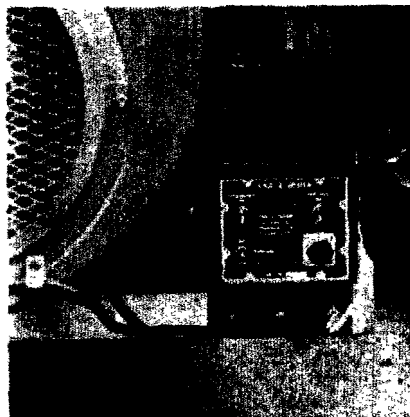

Control Improves Machine Efficiency

Most spray rigs used for fire-proofing or wall and ceiling work have air controls which enable the nozzleman to start or stop the pumping operation without going to the



machine itself. To date, however, no manufacturer has offered a hook-up allowing as many as 15 or 20 variable steps in engine speed by depressing a button at the end of the hose.

Control of engine RPM at the nozzle — a refinement frequently mentioned but not available heretofore — can now be added to any pump equipped with a centrifugal clutch.

Advantages are immediately apparent. The system reduces material waste, which is money down the drain for a contractor, because operators can adjust flow to job requirements. Clean-up expenses are pared to the bone. Material can be placed with hawk and trowel precision, without sacrificing speed and efficiency of mechanical application.

Called Var-E-Speed, the control mechanism operates on a 12-volt

The treatment consists of a freeze, water and rust-inhibitor to meet a one-hour fire need, perhaps a low freezing rating.

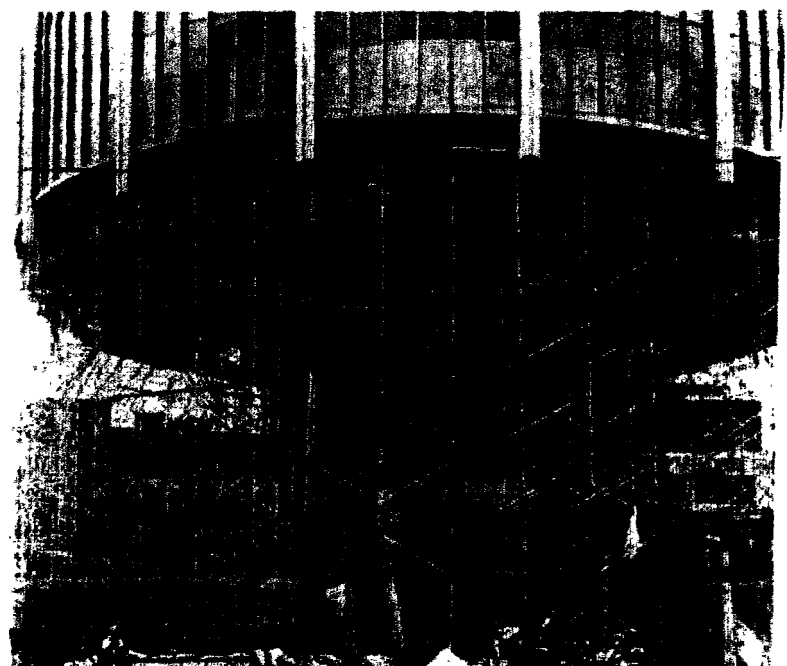

electrical system. Power may be supplied by the machine's battery or a separate lantern type drive which will last for six months.

Var-E-Speed comes in the form of a kit consisting of a unit which actuates the carburetor throttle arm to adjust engine speed, a control box which is the "heart" of the system, and a nozzle assembly with separate buttons for advancing or retarding the throttle.

First two units are mounted on the machine.

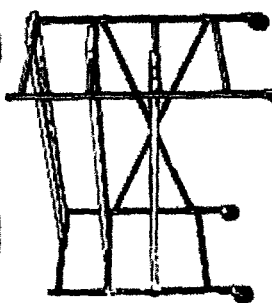

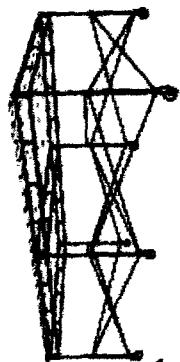

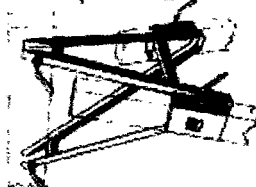

the machine. Transistors, resistors and other electronic components make up the circuitry of the control box. Switches on the box enable the operator at the machine to take control from the nozzleman. Silver plated connectors insure against rust.

Nozzle control buttons are sealed in fiberglass and waterproof. Should an accident occur, the nozzleman would receive no more of an electrical shock than he would from an ordinary flashlight battery. And if any lines are cut or damaged, the engine immediately shuts down to idle speed until the trouble can be corrected.

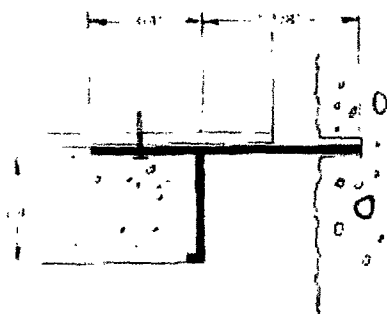
Positive speed control means that the pump will go from standstill to wide open in only two seconds — without the customary time lag characteristic of air control. Of course air leaks no longer have an effect on engine operation. All air put out by the compressor is available for atomizing purposes at the nozzle.

The controls have proved especially effective in fireproofing operations, frequently with two nozzles working off the same machine. A junction block is placed in the line on the floor where work is in progress and a switch assembly provided for each nozzle. Line lengths of 800 ft. and more have been used without difficulty.

The manufacturer also markets a lightweight aluminum cut-off valve which provides additional savings in eliminating waste and cleanup expense. Comparing results on two different high rise buildings, one contractor found he had reduced clean-up costs 50% by using both Var-E-Speed and the cut-off valves — a saving of several thousand dollars.

Molding (pictured): The problem of how to neatly join a plaster soffit to a masonry or other decorative wall has been solved by "T" reveal molding TRM 050. It functions as an adjustable reveal, separating the plaster from the vertical wall section.

It also forms a screed for the plaster, making a clean sharp edge along the soffit. The unit is attached by fasteners through perforations which are subsequently covered, with the horizontal leg inserted into a sawed kerf.

No caulking is required. It adjusts to movement of the building frame. The molding is manufactured of extruded aluminum .050 thick and coated with clear plastic.

New Drywall Panels

A Chula Vista, California firm is producing a new type of drywall panel. The Lamtec Corporation at 780 Anita Street is making the panels from a lamination of gypsum board and paper honeycomb core according to Francis J. Mayers, president.

The panels are 4 feet by 8 feet and are available in thicknesses of 2½, 3½ or 4½ inches. Taping the joints is the same as for conventional drywall, but there is a vertical row of nails to cover. The company plans to eventually develop structural panels as well.

A NEW INTERNATIONAL ASSOCIATION OF WALL & CEILING CONTRACTORS

Thomas McGlone Named President at Las Vegas Meet

Industry grows, so does association. For 52 years, it has tended the interests of contractors specializing in lath and

change. Industry studies of the past decade have shown that lathing and plastering contractors are now engaged in additional fields: acoustics, drywall, painting, concrete pump-decks, curtain walls, etc.

Taking due recognition of this trend, the venerable organization changed its name to International Association of Wall & Ceiling Contractors at the recently concluded annual convention in Las Vegas. Evidence that changing times mean greater strength was found in convention attendance — registration of 820 was second largest in history.

The name change was no spur of the moment step. It was discussed

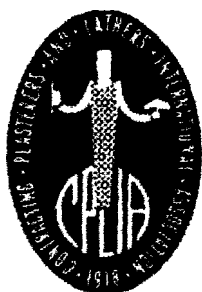

A summary of the more important business taken by Resolutions and By-Law Amendments at the 52nd convention of the CPLIA:

NAME CHANGE

Henceforth the 52-year-old CPLIA will be known as the **International Association of Wall and Ceiling Contractors** and soon a new emblem and other changes will be made to reflect the increasing Diversification of the Industry.

COMPETITIVE INTEREST

Continuing Liaison will be maintained with the Acoustical and Drywall Contractors toward amalgamation of interest and possible eventual merger or consolidation.

NON-INDUSTRY MEMBERS

Membership in the organization is now open to contractors in other fields than lath and plaster and they need not be principally in lathing and/or plastering to join.

BOARD

Over a period the number of members of the Board of Directors will be gradually reduced in order to provide one board member for approximately each 10 members, along with voting rights for Past Presidents.

ANNUAL DUES

Will henceforth be determined by the membership at each annual convention without requiring amendments to the By-Laws. (For this coming year the dues remain as at present.)

JOIN GROUPS

Members are urged to affiliate with the American Subcontractors' Association and the Construction Specifications Institute.

LATHERS-CARPENTERS

While voting for continuation temporarily of "status quo," Carpenters and Lathers are urged to adjust their differences immediately for the industry's benefit and public interest. Official liaison will be established with both the Carpenters and Painters International Unions by the CPLIA.

STILTS

International and Local Unions will be requested to allow the use of Stilts and other such cost-saving equipment where permitted by safety and health regulations.

AREA BARGAINING

The organization will encourage State- and regional-wide bargaining units.

STRIKES-LOCKOUTS

The Governments of Canada and the U.S. will be asked to establish a code of ethics protecting contractors against union strikes and "interim" agreements, and to compensate them for additional costs incurred on Federal work beyond their control at the signing of contracts for work in the future.

APPRENTICESHIP

Broadest support and cooperation with Industry Training programs shall be continued.

NATIONAL AGREEMENTS

Will be encouraged and fostered wherever in the industry best interest as to working conditions, health and welfare, pension programs and jurisdiction.

collecting methods and proper enclosures at construction sites.

On the technical front, discussions centered around bonding agents, form release compounds, plaster to polystyrene, sprayed fireproofing, veneer and rapid plaster, curtain walls, roof decks, wallboard and moveable partitions. Consultant John Bucholtz suggested that the association demphasize participation in activities of the American Society for Testing & Materials. Instead, he said, more effort should be placed on working with model code writing authorities such as BOCA and ICBO.

Wives of delegates enjoyed a full ladies' program, and many joined their husbands in workshop sessions. Chairman of the convention advisory committee was Las Vegas contractor M. J. DiBiase, with Ruth DiBiase in charge of women's activities.

Success Is Learning About Your Business

Delegates to the Las Vegas convention picked and chose among a number of educational programs, each of which was repeated on successive days. Contractors who missed a session the first time could catch it on the next go-round. Registrants occasionally found certain presentations so interesting they attended more than once.

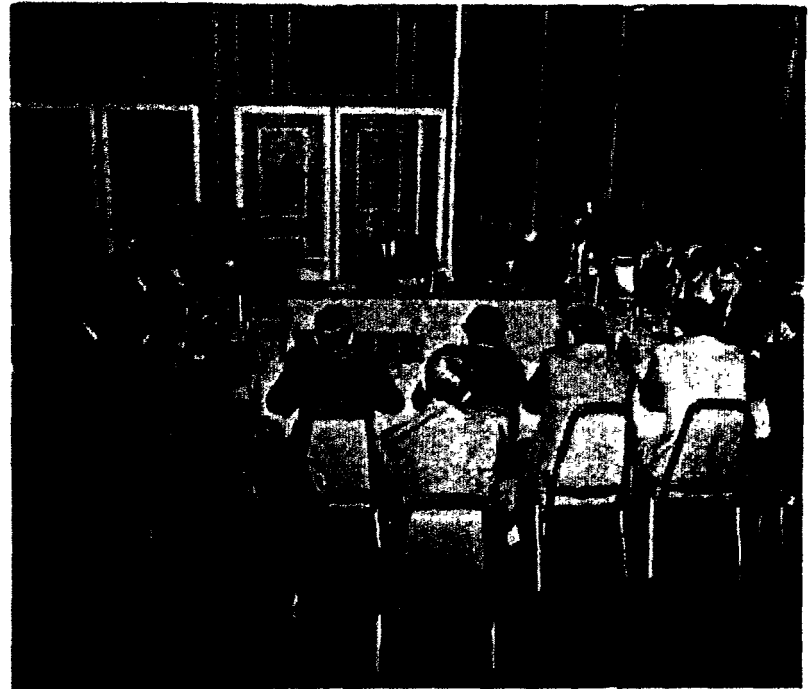
"Success" was the convention theme. Specialists in different fields covered everything from how to make money in flooring to tax implications of the various types of corporate business structures.

Among the subjects:

Concrete Pumping — A highly profitable endeavor for many contractors, who find it a natural tie-in with mechanical plaster application. David Gaston of Thomsen Division, Royal Industries, and R. Richard Stone, Merli Plastering, pointed out advantages of boom-equipped concrete placement rigs and explained operating procedures based on extensive field experience.

A relatively new field, concrete pumping with so-called "small line" equipment has a number of inherent advantages: fast placement, lower cost, efficient operation even in tight and congested areas, and easy access to remote forms.

These features account for the growing popularity of concrete pumps over the more familiar hoist or buggy methods. An application which holds great promise is place-



ment of low slump mixtures where gunite would ordinarily be specified. Production is at least double that of gunite, there is only a fraction of the rebound waste; rocks may be incorporated if desired, and the concrete is stronger. The system has been successfully employed for swimming pool construction, lining drainage ditches, etc.

Taxes — Aggressive tax planning was urged by John Anderson, Los Angeles attorney. Staying well within bounds of the law, he explained, there are many areas calling for individual judgment where an aggressive policy can pare tax bills. For example, depreciable assets should be written off in the shortest possible time at accelerated rates. In the case of real estate, throw highest possible proportion of the pur-

chase price into improvement even supplies — spelling out minimum land valuation in the purchase contract whenever practicable.

Anderson described a typical planned business structure. The operating company is a corporation whose assets consist primarily of working capital. It makes payments to two investment entities which own buildings and real estate, other machinery and equipment. Owners can legally double profits by establishing irrevocable trusts, income accruing via partnerships in the company owning machinery and equipment.

As for outside investment, attorney suggested shopping centers as a good way to go. If the investor can earn 20% to

and assets should be traded in a public company, which is accomplished without payment in capital gains.

Ornamental Plaster — This session was conducted by contractors Catani and Bill Wood, along Charles F. Clay, publisher of *Plaster & Ceilings*. A revival in ornamental plastering will depend on consideration being given both to old forms and new materials. The session concluded.

Ornate embellishments of a generation or two ago are no longer at the top of the popularity list, but cast and run molds can be used in the most modern and ornate forms. As for materials, contractors were reminded of the use of a fine, an exceedingly light and economical substance has been used to achieve very unusual effects. Casting ornamental plaster in a variety of ways has also proved an attractive and ornamental treatment.

Lists agreed on the necessity of establishing performance standards for ornamental work and making data available to architects and builders. It was also agreed to establish a national library of information relating to ornamental plaster to be helpful to the industry.

Labor Problems Discussed

Convention speakers and workshop sessions explored the many facets of labor relations during the Las Vegas meeting. Several inter-

national union representatives made addresses and some resolutions thrown into the hopper concerned labor subjects.

At the opening general session, Terence O'Sullivan of the Laborers International Union decried federal and state construction cutbacks and called for use of government funds to train workers needed for the huge building task ahead.

William Sidell, Carpenters International Union, reminded contractors that his general president had

informed all locals that they were to supply men to CPLIA members whenever requested. The relationship has worked out very well, he reported, and a majority of association members have added carpenters to their payrolls.

Newark labor attorney Vincent Apruzzese pointed out that unions in the building trades are operating on a \$75 million budget. Apruzzese conducted brainstorming sessions on labor negotiation procedures and how to overcome jurisdictional problems resulting from diversification.

Sal Maso, general president of the VW & MIU; Tom Murphy, president of BM & PIU; and John Hauck, secretary-treasurer of OP & CMIA spoke at the final general session, the most part the same people are now sitting at the bargaining table. They pledged continuing cooperation with the association and men-

tioned some of the major problems facing the industry.

Murphy touched on the prevalence of dissent throughout the country and asserted that sub-standard residential areas should be rebuilt at government expense regardless of the cost involved. Hauck stated that there are 3,500 fewer active plasterers than two years ago and estimated that a net increase of 30,000 additional journeymen will be required during the next 10 years.

Portland, Ore. contractor Carl Halvorson, president of the Associated General Contractors of America, believes that the construction industry is on a treadmill as far as labor relations are concerned. For

as 10 years ago, he pointed out. Then why is it, he asked, that 60% wage increases are now being demanded instead of the more modest former requests?

Halvorson believes unions have most to lose by the self destructive inflationary spiral which they are fostering. In his opinion full em-

ployment has created inexorable power in the hands of labor. Laws have been written to protect workers against unemployment, said, and are no longer valid in a system based on productivity. CORNERSTONE

Many sole proprietors are in the position of having no one in their families or employ either capable of, interested in or willing to operate their businesses after their deaths. Generally, the business success they have enjoyed, is tied irrevocably to their personalities and good will. The proprietor's death leaves nothing to be continued and there is, as a result, no alternative except to sell only assets.

An architectural firm also falls into this class. Not only may the professional skill and experience be non-transferable, but the legal need for professional qualifications may preclude a family member from stepping into the decedent's place.

It may be advisable to liquidate the business if the death of the proprietor leaves the business without leadership capable of maintaining its future prosperity.

Also, the capital needs of the business following the death of the

It is evident that the friendly banker is less likely to extend credit to the business' successor manager than he was to the proprietor with whose character and business discernment he was familiar.

Finally, sound Estate Planning demands that the planner measure the investment risk that would arise from the continued operation of the business. A businessman is willing to risk substantially all his assets in his business during his lifetime, but should realize that after his death his family should not be subjected to any of this risk. After all, their need is for investments that promise security of principal and regularity of income. An investment in a small business seldom can make those promises.

The solution to this problem, is relatively simple. By maintaining a properly drawn will and an adequate amount of life insurance on the owner's life, the estate can be liquidated in an orderly fashion.

many cases the most dramatic escalation of wage demands.

Inflation, which has been produced in large measure by labor costs that have outrun productivity, provides the rationale of union negotiators for ever-increasing wage demands to buck "the rising cost of living." At the same time, the government credit squeeze and higher taxes have begun to slow the flow of orders and to clip profits. This has been done, of course, to fight inflation.

This, therefore, would be a mighty good year for a lot of company frankness. Most employes, when facts can be trusted and when they are spelled out so they can be understood, are inclined to be reasonable.

But honesty can't be a sometime thing. If companies are to tell the truth when things are tough, they'd better be prepared to do so when things are better.

Maybe, in the long run of labor relations, that would be a great idea, anyway.
