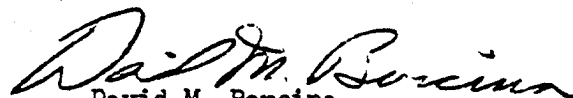
FUTURE ORGANIZATION
