WCF in Montana – Digital Roundtable Announcement

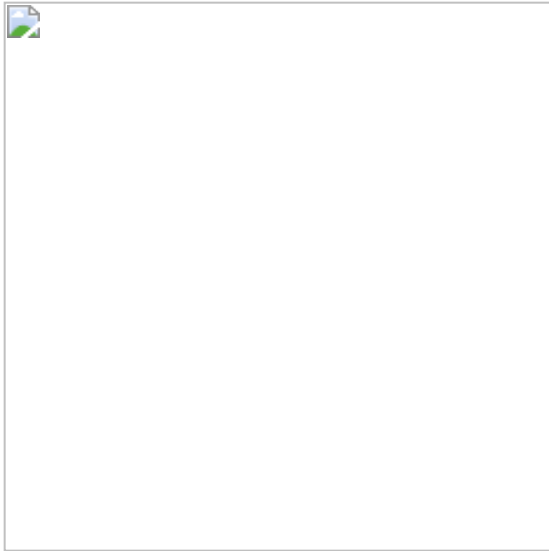

Digital Connect: Rural Broadband & Previous Policy Forums



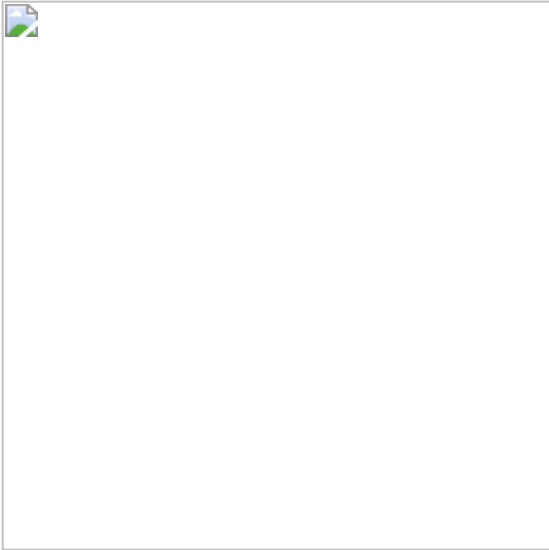
