

WORKMEN'S COMPENSATION CLAIMS

The Celotex Corporation, as Successor-in-Interest to the Philip Carey Manufacturing Company, believes that the following individuals may have filed a compensable Workmen's Compensation Claim for benefits associated with exposure to Asbestos Dust. Much of this information was recently discovered in connection with current Asbestos Litigation. Accordingly, The Celotex Corporation is unable to verify if, or when, Philip Carey became aware of the claims listed below. Many of the claims do not list Philip Carey as a defendant and it is believed that Philip Carey's only connection with the claim is the fact that the claimant may have worked for Philip Carey sometime prior to filing the claim.

It must be emphasized that Celotex is not admitting or verifying the authenticity of any claim listed below. Rather, the information is being supplied because it may lead to the discovery of relevant and admissible evidence.
