LETTER-BUT NO BLOCKS.

But instead of the blocks, Robb received, a letter from the firm that said:

"You understand under order of the War Production Board (WPB) No. 1280 H is necessary to make telegraph application to the building maintenance division, W.P.B., Washington, D. C., for authority to purchase these blocks and follow with four copies of Form WPB 1001, copy of which is attached hereto."

"You can secure these forms from your local WPB office. They will wire you a case number which in turn must be forwarded to us before shipment can be made."

"Later upon your receipt of approved copies of your application the original must be mailed to us."

"Trusting we have made the above clear, we are yours truly."

Robb said he telegraphed the firm to send the blocks now and let him carry the responsibility of handling the red tape later.
