INTERNATIONAL SMELTING AND REFINING COMPANY

The Anaconda Copper Mining Company on May 26, 1914 acquired for 329,274 shares of \$25.00 par value common stock, and cash payments of \$23,066.00 to other stock holders, and \$9,059,867.68 for other properties, assets and good will, 100,000 shares of the International Smelting and Refining Company stock.

The properties of the International Smelting and Refining Company acquired by the Anaconda Copper Mining Company consisted of:

Lead Smelter - Tooele, Utah
Copper Smelter - Tooele, Utah
Copper Smelter - Miami, Arizona (In process of construction)
Tooele Valley Railroad
International Lead Refining Company
Lead Refinery - East Chicago, Indiana
Barrick Copper Works
Copper Refinery - Perth Amboy, N. J.

The International Smelting Company was incorporated under the laws of the State of Montana on May 13, 1914. On May 27, 1914, 150,000 shares of stock of \$100.00 par value was authorized and 90,000 shares (representing outstanding stocks) was issued to Anaconda Copper Mining Company for the properties, business and assets of the:

Lead Smelter - Tooele, Utah
Copper Smelter - Tooele, Utah
Copper Smelter - Miami, Arizona

The remaining properties of the Anaconda acquisition were set up as separate companies:

Tooele Valley Railroad
International Lead Refining Company
Barrick Copper Works

The Anaconda Copper Mining Company on November 30, 1915 received 25,000 shares of \$100.00 par value stock of International Smelting Company in exchange for advances.

The charter of the International Smelting Company was amended on December 21, 1914 to read International Smelting and Refining Company and the par value of the stock was changed from \$100.00 to \$75.00, and 50,000 additional shares were authorized.

INTERNATIONAL SMELTING AND REFINING COMPANY

On December 31, 1934 the International Smelting and Refining Company acquired from the Anaconda Copper Mining Company 20,000 shares Preferred \$25.00 par value, and 40,000 shares Common \$25.00 par value of Haritan Copper Works stock, in exchange for \$8,000,000.00 15 year 6% Debenture bonds and 27,600 shares of International Smelting and Refining Company stock \$75.00 par value; and 7,500 shares of International Lead Refining Company stock \$100.00 par value, in exchange for \$2,000,000.00 15 year 6% Debenture bonds and 2,400 shares of International Smelting and Refining Company stock, \$75.00 par value.

The Haritan Copper Works and the International Lead Refining Company were dissolved December 31, 1934.

Reorganized December 31, 1934 -

2,000 shares authorized \$1.00 par - \$2,000.00.

1,000 shares authorized \$1.00 par - \$1,000.00.

On October 1, 1936 the International Smelting and Refining Company acquired from the Anaconda Copper Mining Company 13,650 shares of Anaconda Lead Products Company stock in exchange for 13,500 shares \$75.00 par value of International Smelting and Refining Company stock.

The Anaconda Lead Products Company was dissolved October 31, 1936.
