April 27, 1965

The Chairman called the meeting to order at 6:10 P.M.

The Secretary reported a quorum was present.

The minutes of the previous meeting of December 8, 1964 were approved.

It was the consensus that Item Numbers 2 through 5 on the agenda of April 9, 1965 be grouped as follows for consideration:

Print proceedings of Annual Meeting, Joint Session on Lead and Zinc	1,000.00
Total	<u>\$9,000.00</u>

A motion was made, seconded and unanimously carried approving the requested expenditures of \$9,000.00 to be taken from the Contingency Fund.

REPRINT "IMPROVED SOUND BARRIERS EMPLOYING LEAD"

The Executive Vice President reported that copies of L.I.A.'s brochure "Improved Sound Barriers Employing Lead" were no longer available and because of the basic technical information it contains, he recommended that it be reprinted at an estimated cost of \$1,000.00.

A motion was made, seconded and unanimously carried approving the reprinting of "Improved Sound Barriers Employing Lead" at a cost of \$1,000.00 to be taken from the Contingency Fund.

LEAD AND ZINC INFORMATION CENTER

The Executive Vice President reported that he had received a letter dated March 5, 1965 from Battelle Memorial Institute suggesting that they set up and manage a Lead or Lead and Zinc Information Center. He further reported that the letter outlined the philosophy behind such an information center but that no estimate of cost was given.

After some discussion, it was agreed that there was no need at this time for such an information center outside the Association.

LEAD IN CHEMICAL CONSTRUCTION

The Executive Vice President reported that the L.I.A. had recently surveyed the lead burning contractors in the U. S. and the results indicated that lead was replacing some of the newer materials and that there appeared to be a trend back to lead in some areas of usage. As a result, he stated, a promotional program for lead in the chemical industries may be presented to the committee at the budget meeting in the Fall.

LE-36 - HIGH SPEED LEAD PLATING

The Research Director reported that \$25,000.00 had been approved in the 1965 budget for this project but that an additional \$15,000.00 was required to meet the demand for lead plated steel samples for evaluation by Chrysler Corp.

A motion was made, seconded and unanimously carried approving the expenditure of an additional \$15,000.00 to be taken from the Undesignated Research Fund for LE-36 - High Speed Lead Plating.

LE-63 - LEAD COATING OF CONCRETE

The Research Director reported that a market study requested at the last meeting had been made and distributed to the Committee. At a question, the Research Director stated that \$10,000.00 would probably be sufficient to get this project underway.

A motion was thereupon made, seconded and unanimously carried approving \$10,000.00 to be taken from the Undesignated Research Fund for the project LE-63 - Lead Coating of Concrete.

There being no further business, the meeting adjourned at 6:45 P.M.
