Dear Colleagues,

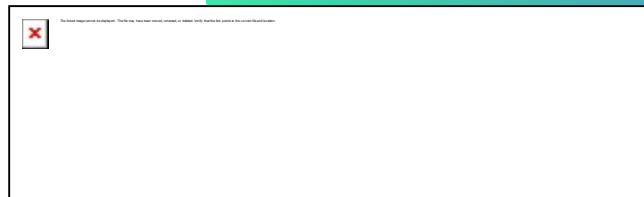
The Commission adopted the attached ATP (Adaptation to Technical Progress) of CLP, introducing new harmonised classifications in Annex VI.
