SUBJECT: Results of Case-Control Studies of Acute Myeloid Leukemia and Non-Hodgkin Lymphoid Neoplasms in Shanghai: Environmental and Occupational Risk Factors by Subtypes of the WHO Classification

Shell Companies are submitting the following information under TSCA 8(e), because it may constitute substantial risk information not previously known to the Administrator.

At the 2009 Benzene Conference in Munich on 08 September 2009, results of case-control studies of Acute Myeloid Leukemia (AML) and Non-Hodgkin Lymphoid Neoplasms (NHLN) were presented. Results indicate an increase in the NHLN subtype follicular lymphoma (FL) associated with certain occupational categories. The significance of the results is uncertain due to how exposures were assigned and is thought to be a weakness in the study. It was noted that the EPA staff member Bob Sonawane was present at the conference.

Note: Shouldn't the above paragraph indicate that there is an association with benzene exposure? I thought that 8(e)s had to be linked to a chemical(s). The way it is stated only links the adverse effect with "certain occupational categories".

"The significance of the results is uncertain due to how exposures were assigned and is thought to be a weakness in the study."

This sentence is a little awkward. If I were to diagram this sentence, it could read, "The significance of the results is thought to be a weakness in the study."

Consider: "The significance of the results is uncertain due to how exposures were assigned. The exposure assessment is thought to be a weakness in the study."
