I am not sure that you have met Mr. Loder. He is now associated with us here, with an office on the 36th floor. He has been on a retainer for us for years in connection with matters involving personal injury and insurance generally. He has been practicing law in New York for thirty-four years and during most of it in the trial of negligence cases in behalf of the defendant and insurance companies. He gained the reputation, and I think very deservedly so because I have heard him try a number of them, of being one of the few topnotchers in Greater New York in that connection. For some years he was general counsel for the Travelers Insurance Company, and until May 1st had been general counsel for the Standard Accident Insurance Company for a number of years.

He gave up his practice on April 30th because he has had some heart trouble for several years and his physicians advised him that he must give up trial work. He is not going to engage in the general practice of the law - he has an arrangement with us by which he will devote three days a week in our service on general legal matters. Mr. Loder has requested me to ask you if he could have the transcript of this case after it has served your purpose. Upon its receipt and after going over it carefully he will be pleased to return it to you.

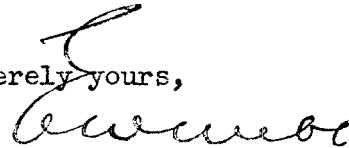
