It is a unified, voluntary effort on the part of industry and is a symbol of industrial initiative and leadership in meeting its responsibility to protect the health of workmen, employees of common carriers, consumers, and the general public from adverse effects of industrial progress.

The Foundation provides industry with a centralized agency for cooperation and collaboration in problems of mutual interest.

Through its professional staff, research facilities, and accumulated technical information, it assists industry in developing industrial hygiene and occupational health programs; provides current information on toxicity, health hazards, analytical methods and control procedures; conducts field studies and laboratory research and serves as a common meeting place for seminars, discussionals, training courses, and instruction on specific or general health problems.

Industrial Hygiene Digest, published monthly by the Foundation, contains abstracts of the current world's literature on industrial hygiene, occupational health, and related subjects.

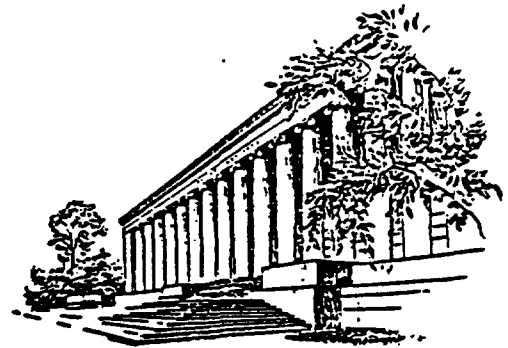
