I just wanted to touch base with you and keep you in the loop....I will again and finally be the Secretary's advance representative for his upcoming trip to Las Vegas for SCI.

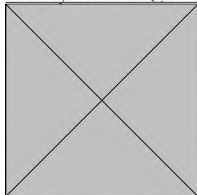
