I have not talked to you about this case since our telephone conversation of July 7. At that time, you indicated that you would review your file regarding settlement and discuss the alternative possibilities with Sherwin-Williams. As I indicated in my June 29 letter to Gerald Childrey, C. C. Perkins is demanding \$80,000 and two years open medical to settle this case. I still think this is actually a pretty reasonable settlement offer since [REDACTED] will be disabled for life. I feel sure that he would come off this sum to a certain degree. Moreover, a structured settlement must be economically feasible for Sherwin-Williams.
