Dear Doctor Sanders:

Thank you for your letter of 8 July, 1953, with the accompanying results of lead analyses on samples of urine and blood on Messrs. [REDACTED], [REDACTED] and [REDACTED]. I find that my records do not reveal any more specific reason for the sampling than your records, but I do recall the circumstances under which it was decided to send you these samples. I was somewhat concerned regarding the possibility of toxic exposure of Mr. [REDACTED] to Aviation Petrol. He is the Mechanic at our office at the Airport and as such is frequently working on the Pumping Mechanisms in the tank trucks and in addition to this exposure to Aviation Petrol, he was in the habit of using this Petrol as a cleansing agent for small parts, etc. It is estimated prior to correction of the situation, this man's hands were in contact with the Aviation Petrol, 50 - 75% of his working time. Blood smears taken and examined locally in the laboratory of Dr. O. C. Trainor, showed some stippling. Urinary lead determination done at Esso Laboratories showed a border line high (0.107 mg. Pb/Liter) lead content. This situation was discussed with you at the time of your visit to Winnipeg about September, 1952, and at that time, you offered to have the above estimations performed on [REDACTED] and suggested that you send containers for similar estimations to be done on our TEL exposed employees at the Winnipeg Refinery. These samples submitted on Messrs. [REDACTED] and [REDACTED] were therefore in the nature of routine surveillance samples.

I am indeed sorry I was unable to meet you on your last visit here and would like to do so on your next or some future visit if you have the time available.

Dear Doctor Tisdale:

I have a copy of a letter written to you by my secretary, Mrs. Rahe, on June 18, written at my request and stating that the results of lead analyses on samples of urine and blood on the four men, [REDACTED] and [REDACTED] were inconsequential. I am [REDACTED] actual results of these analyses and also the results of urine and blood of a Mr. [REDACTED], which were taken at a later date. The result [REDACTED] significant and would indicate that there had been no recent occupational exposure of any significance.

It seems to me that I did know at one time the specific reason for these samples being submitted, but I have not been able to find any notation of that reason, nor can I remember specifically what the reason was. We would like to know for our records if these samples are submitted only as a routine check on the men who have some possibility of lead absorption or whether there was for some reason or other a knowledge of some possibility of an actual exposure.

We are very glad to run the samples in any event, but are always interested in the specific reason for the analyses.

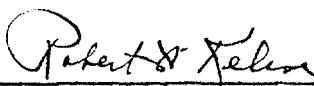

The urinary lead concentration is also normal, the volume of the sample being somewhat lower than the optimum for yielding a representative result.
