COMPROMISE AND RELEASE
AGREEMENT

The parties hereto, for the purpose of compromise only,
hereby submit the following agreed statement of facts:

1. Paul J. Greischar, employee herein, born September 11
claims that he was employed in California and other states where
the place of hiring was California during the years 1943 through
July 1, 1965, at a variety of places by various employers, during
which period he sustained an injury consisting of pulmonary and
chest disability, the nature and extent of which is more fully
forth in the medical reports of record, which are hereby incorp-
ated by reference as if set out in full.

During such period of employment as described above, applicant
was employed by certain employers whose names or their insurance
carriers during such periods are set forth below.

2. The actual weekly wages of the employee at the time of
injury were sufficient to entitle him to a maximum weekly compe-
sation rate.

3. The employee's present disability is in dispute. The
applicant has returned to work and is working on a part time
basis.

4. (a) No temporary disability has been paid and it is agreed
that applicant's condition became permanent and stationary for
permanent disability purposes as of July 1, 1965.

(b) Permanent disability indemnity has not been paid to
employee.

5. The parties hereby agree to settle any and all claims on account of said injury by the payment of the sum of \$8,735.00; said sum to be paid by the following entities and in the amounts stated below:

6. The amount of medical and hospital expense incurred or paid by the employee is in dispute, as is the amount of unpaid bills. Unpaid and future medical and hospital expenses are to be assumed by the employee, applicant herein.

7. The name and address of employee's attorneys, Smith, Parris, Faduck & Clancy, 315 Financial Center Building, Oakland 12, Calif.

8. Said attorneys request a fee of \$375.00. Amount of

2 9. The reason for compromise is that there is a serious and
3 substantial dispute between the parties as to both the nature and
4 extent of disability, if any, caused by the variety of employments
5 in California, as indicated above. The parties wish to avoid the
6 further expense and hazards of litigation by means of the within
7 Compromise and Release agreement.

8 10. It is specifically understood and agreed that this agree-
9 ment encompasses all periods of employment by the above mentioned
10 employers, whether such periods are specifically set forth above
11 or not, and includes all employers insured by the above mentioned
12 insurance companies, whether or not previously joined in this action.

13 11. The undersigned requested this Compromise and Release
14 agreement be approved.

15 12. Upon approval of this Compromise and Release agreement by
16 the Workmen's Compensation Appeals Board, a panel thereof, a
17 Commissioner, or a Referee, and payment in accordance with the
18 provisions hereof, said employee releases and forever discharges
19 said employers and insurance carriers from all claims and causes
20 of action, whether now known or ascertained, or which may hereafter
21 arise or develop as a result of said injury, including any and
22 all liability of said employers and said insurance carriers and
23 each of them to the dependents, heirs, executors, representatives,
24 administrators or assigns of said employee.

25 13. It is agreed by all parties hereto that the filing of
26 this document is the filing of an application for adjustment of
27 claim on behalf of the employee, and that the Appeals Board may
28 in its discretion set the matter for Hearing as a regular application
29 reserving to the parties the right to put in issue any of the facts
30 admitted herein, and that if Hearing is held with this document used
31 as an application the defendants shall have available to them all
32 defenses which are available as of the date of filing of this

document, and that the Appeals Board may thereafter either approve said Compromise Agreement and Release or disapprove the same and is Findings and Award after Hearing has been held and the matter regularly submitted for decision.

14. For the purpose of determining the lien claim filed herein for the unemployment compensation disability benefits which have been paid under or pursuant to the California Unemployment Insurance Code, as aforementioned, it is agreed that applicant's permanent disability, if any, commenced July 1, 1965; further that any unemployment compensation disability benefits paid out after July 1, 1965 was for a cause and condition unrelated to the industrial injury herein.
