I am contacting you on behalf of [DuPont](#), a premier multi-industrial company.

Within the EU, DuPont has significant polymer based (non-fluoropolymer) production assets used for health and human life applications.

Ahead of the public consultation on the universal PFAS restriction, DuPont has generated a socio-economic analysis including an analysis of potential substitutes, together with a solid data package which covers mobility, exposure, and risk assessment for two PFAS used in the manufacturing process for these applications.

Beyond the existing risk management, DuPont is actively prioritizing substitution and exploring options for removing PFAS from its manufacturing processes.

We would like to present to you the current generated data and discuss with you this unique case to facilitate the regulatory efforts on the PFAS restriction.
